VII. ADOPTION OF MINUTES:

Mr. Auzenne referenced the guidelines of the State and the importance of the State reviewing the contract to ensure that there are no mistakes that would hinder the project going forward in the future. Chairman Laiche recommended that the GEC Contract be placed on the July agenda and the Commission will take it up at that time. Commissioner Williams made the motion to authorize Chairman Laiche to sign on behalf of the Port as Chairman of the Commission for the GEC contract pending State approval of the proposed contract. Commission Webb seconded the motion to authorize. There was no further discussion and the motion to authorize passed unanimously.

2023-2024 - Budget Meeting

June 20, 2023

I. CALL TO ORDER:

Chairman, Barry Laiche called to order the 2023-2024 annual budget meeting of the Avoyelles Parish Port Commission, 5:09 p.m. on June 20, 2023, at Port Commission Headquarters 170 Honeybee Lane, Simmesport, Louisiana, 71369.

III. PROPOSED BUDGET REVIEW:

The commissioners were presented with a copy of the 2023-2024 proposed budget to review. Commissioner Laiche's review of the proposed budget determined that there may need to be amendments made to the budget due to projects that are in the planning phase but have not begun. Mr. Auzenne advised that if revenues or expenses exceed or are below five percent of the budgeted amount, an amendment will have to be made to the budget. Income for the 2023-2024 budget year will remain the same as expected. All expense items were adjusted for inflation and a significant increase in insurance premiums. Chairman Laiche recommended to the commissioners that the 2023-2024 annual budget be adopted as proposed and have the expectation that with liquid fertilizer tank

project forthcoming and the workshop amendments will have to be made to the budget. Commissioner Williams made the motion to adopt the budget for the year 2023-2024. Commissioner Pierite seconded the motion. There was no further discussion and the motion to adopt the 2023-2024 annual budget passed unanimously.
