

STATE LICENSING BOARD FOR CONTRACTORS

March 19, 2015

Mr. Stuart led the members and audience in the Pledge of Allegiance.

Judge Darrell White gave the invocation, introduced himself, and advised those present of his duties.

Mr. Lambert made a motion to accept the Minutes of the **February 19, 2015** regular meeting, and Mr. Cloutre seconded. The motion passed.

Mr. McDuff introduced guest Ronald Burrough with the Attorney General's office.

NEW BUSINESS

C. QUALIFYING PARTY HEARING(S):

1. **FINLO CONSTRUCTION COMPANY, INC.**, Hattiesburg, Mississippi – La. R.S. 37:2156.1, Sec. 103 Rules and Regulations of the Board.

Ms. Dupuy gave a summary of the allegations. No one was present on behalf FINLO CONSTRUCTION COMPANY, INC. Ms. Sims entered into evidence the exhibit packet and it was admitted. Mr. Stuart made a motion to suspend the commercial license for FINLO CONSTRUCTION COMPANY, INC allowing the license to be reinstated by staff if the Qualifying Party is replaced. Mr. Cloutre seconded. The motion passed.

D. JUDGMENT(S):

1. **BBT CONSTRUCTION MANAGEMENT, LLC**, Thibodaux, Louisiana – La. R.S. 37:2150-2192, (A)(8) and (A)(9), 2156.1(D)(1) and Section 115 of the Board's Rules and Regulations.

Ms. Dupuy gave a summary of the allegations. No one was present on behalf of BBT CONSTRUCTION MANAGEMENT, LLC. Ms. Sims entered the exhibit packet into evidence and

it was admitted. Ms. Sims stated that a representative for the company requested a continuance for this matter. The continuance was granted until the April 16, 2015 hearing.

2. **CHRIS MATISE**, Kenner, Louisiana – La. R.S. 37:2150-2192, (A)(8) and (A)(9), 2156.1(D)(1) and Section 115 of the Board's Rules and Regulations.

Ms. Dupuy gave a summary of the allegations. CHRIS MATISE was not present. Ms. Sims entered the exhibit packet into evidence and it was admitted. Mr. Jones made a motion to revoke the commercial license for CHRIS MATISE. Mr. Gallo seconded. The motion passed.

E. **COMPLIANCE HEARING(S):**

1. Matters 1a - 1h were consolidated.

- a) **CA DEVELOPMENT, LLC**, San Antonio, Texas – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by CA DEVELOPMENT, LLC. Mr. Graham made a motion to accept the settlement offer as presented. Mr. Gallo seconded. The motion passed.

- b) **EDNA LUMBER CO., INC.**, Edna, Texas – La. R.S. 37:2158(A)(4).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by EDNA LUMBER CO., INC. Attorney Brett Cobb was also present on behalf of EDNA LUMBER CO., INC. Mr. Graham made a motion to accept the settlement offer as presented. Mr. Gallo seconded. The motion passed.

- c) **BLACK HAWK CONCRETE CONSTRUCTION, LLC**, Shreveport, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by BLACK HAWK CONCRETE CONSTRUCTION, LLC. The settlement offer was a combined offer for matters E. 1c. and E. 4. and included a no contest plea. The decision on this matter was deferred until E. 4. on the agenda was heard.

- d) **JUAN MARTINEZ D/B/A JYG MARTINEZ MASONRY**, Dallas, Texas – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. Juan Martinez was present on behalf of JUAN MARTINEZ D/B/A JYG MARTINEZ MASONRY and was sworn in. Mr. Martinez entered a no contest plea. Mr. Jones made a motion to accept the plea. Mr. Cloutre seconded. The motion passed. Mr. Martinez gave a statement. Mr. Stuart made a motion to fine JUAN MARTINEZ D/B/A JYG MARTINEZ MASONRY \$500 plus \$500 administrative costs allowing that the fine to be waived if the company obtains a license within 90 days.

- e) **TC CONSTRUCTION, LLC**, Arlington, Texas – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by TC CONSTRUCTION, LLC. Mr. Graham made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Gallo seconded. The motion passed.

- f) **HARBORFRONT INTERIORS INCORPORATED**, Muskegon, Michigan – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by HARBORFRONT INTERIORS INCORPORATED. Mr. Graham made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Gallo seconded. The motion passed.

- g) **METROPLEX REFRIGERATION, INC.**, Fort Worth, Texas – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by METROPLEX REFRIGERATION, INC. Mr. Graham made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Gallo seconded. The motion passed.

- h) **FEDERAL HEATH SIGN COMPANY, LLC**, Delaware, Ohio – La. R.S. 37:2158(A)(4).

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by FEDERAL HEATH SIGN COMPANY, LLC. Mr. Graham made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Gallo seconded. The motion passed.

2. a) **JERRY KACHEL BUILDERS, INC.**, Spring, Texas – La. R.S. 37:2158(A)(4).

Ms. Hughes gave a summary of the allegations. Greg Knowlton was present on behalf of JERRY KACHEL BUILDERS, INC. and was sworn in. Mr. Knowlton entered a guilty plea. Mr. Clouatre made a motion to accept the plea. Mr. Stuart seconded. The motion passed. Mr. Knowlton gave a statement. Mr. Dupuy made a motion to fine JERRY KACHEL BUILDERS, INC. \$2000 plus \$500 in administrative costs, place the company on a one year probation allowing that if the company does not comply with the probation requirements the license will automatically be revoked, and the Qualifying Party on record for the company to retake the Business and Law examination within 90 days. Mr. Weston seconded. The motion passed with one nay.

- b) **JOSEPH LAMB D/B/A JOE LAMB CONSTRUCTION**, Alexandria, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. No one was present on behalf of JOSEPH LAMB D/B/A JOE LAMB CONSTRUCTION. Investigator Scott Corley was called to the stand and was sworn in. Mr. Corley reviewed the exhibit packet. Ms. Sims entered the exhibit packet into evidence and it was admitted. Mr. Lambert made a motion to find JOSEPH LAMB D/B/A JOE LAMB CONSTRUCTION to be in violation. Mr. Clouatre seconded. The motion passed. Mr. Lambert made a motion to assess a fine of \$5000 plus \$500 in administrative costs. Mr. Weston seconded. The motion passed.

Ms. Hughes gave a summary of the allegations and read the settlement offer presented by WILLIAM DEROZAN D/B/A WILLIAMS & SONS AUTOMOTIVE & TOWING. Attorney Tom Nelson was present on behalf of the company. Mr. Nelson gave a statement. Mr. Stuart made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Lambert seconded. The motion passed.

- b) **ELC CONSTRUCTION CO.**, Brookshire, Texas – La. R.S. 37:2158(A)(3),(A)(4),(A)(5) and Rules and Regulations of the Board Sec. 109(A).

Ms. Hughes gave a summary of the allegations. Attorney Cy D'Aquila, Jr. was present on behalf of ELC CONSTRUCTION CO. Mr. D'Aquila entered a no contest plea. Mr. Stuart made a motion to accept the plea. Mr. Lambert seconded. The motion passed. Mr. D'Aquila gave a statement. Mr. D'Aquila presented a settlement offer to the board. Mr. Lambert made a motion to accept the settlement offer as presented. Mr. Stuart seconded. The motion passed.

- c) **ROBERT COLVIN D/B/A COLVIN CONSTRUCTION**, New Roads, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. Attorney Cy D'Aquila, Jr. was also present on behalf of ROBERT COLVIN D/B/A COLVIN CONSTRUCTION. Mr. D'Aquila entered a no contest plea. Mr. Stuart made a motion to accept the plea. Mr. Lambert seconded. The motion passed. Mr. D'Aquila presented a settlement offer to the board. Mr. Dupuy made a motion to reject the settlement offer as presented. Mr. Weston seconded. The motion passed. Mr. D'Aquila gave a statement. Mr. Dupuy made a motion to reconsider and accept the settlement offer previously presented, which included an application for licensure to be completed. Mr. Clouatre seconded. The motion passed.

- d) **JOHN SAIZON, JR.**, New Roads, Louisiana – La. R.S. 2160(A)(1).

Ms. Hughes gave a summary of the allegations. JOHN SAIZON, JR. was present and sworn in. Mr. Saizon entered a no contest plea. Mr. Meredith made a motion to accept the plea. Mr. Clouatre seconded. The motion passed. Mr. Saizon presented a settlement offer to the board. Mr. Lambert made a motion to accept the settlement offer as presented, which included an application for licensure to be completed within 90 days. Mr. Clouatre seconded. The motion passed.
