• Approval of JEDCO 2014 Financial Audit Report

Disclosures. Dr. Vinicio Madrigal motioned to accept the Audit Report as presented; seconded by Roy Gattuso. The motion passed unanimously.


- Approval of Amended and Restated Finance Procedures Manual for Loan Operations and Internal Controls – Alberto Queral In April 2015, SBA issued a "final rule" setting forth updated SBA Policies. The Finance staff updated the Finance Program's existing Policy and Procedures Manual and included SBA language with regards to the Internal Control requirements. Dr. Vinicio Madrigal motioned to approve the Amended and Restated Manual; seconded by Roy Gattuso. The motion passed unanimously.
- Resolution attesting to Compliance with guidelines set forth within the EDA Revolving Loan Fund Administration Plan – Alberto Queral Dr. Vinicio Madrigal motioned to approve the resolution attesting to JEDCO's support of the Community Economic Development Strategy and that JEDCO remains in compliance with all operational aspects as set forth within the plan and EDA guidelines. The motion was seconded by Roy Gattuso and passed unanimously.
- Resolution authorizing Executive Director to execute conveyance of land to Delgado (deferred from April 30, 2015 meeting) - Lacey Bordelon Dr. Vinicio Madrigal motioned to defer this agenda item to the June 25, 2015 Executive Committee meeting; seconded by Roy Gattuso. The motion passed unanimously.

• Dr. Vinicio Madrigal motioned to accept the report as presented; seconded by Bruce Dantin. The motion passed unanimously.

- Bayou Segnette Harbor The JEDCO staff will be meeting with the Mayor Shaddinger to discuss the Segnette Harbor and the City of Westwego's planned development in surrounding area.
- Legislative Update JEDCO submitted an official position opposing HB 629 and HB 635. Both bills passed the House and are pending in the Senate. Jerry will inform the Board as updates are available.
- Avondale Update There has been more activity since the recent announcement related to finding a reuse, or possible sale of the property. Jerry, Michael Hecht, and Lou Hose of Avondale-Huntington Ingalls Inc. plan to meet every two weeks to discuss prospects.
