III. Unfinished and New Business

A resolution approving a "Lease Agreement and Agreement to Issue Bonds" with US Foods, Inc. and any and all additional documents and certificates deemed necessary in connection with the granting of a favorable payment in lieu of tax arrangement and the potential issuance of not exceeding \$51,900,000 in aggregate principal amount of taxable and/or tax-exempt Revenue Bonds of JEDCO for the acquisition and construction of a food warehouse and distribution facility in Marrero, Louisiana; and providing for related matters – Lacey Bordelon

JEDCO's bond counsel, David Wolf of Adams and Reese LLP, and Ms. Bordelon provided the background and details of the Lease Agreement and Agreement to Issue Bonds in connection with the PILOT which was approved by the Parish Council on June 27th. Mr. Jessup French, with US Foods, and Mr. Chris Schastok, with CBRE Advisory & Transaction Services, spoke on behalf of US Foods; encouraging the Board's approval of the resolution.

Roy Gattuso motioned to approve the resolution, seconded by Larry Katz. The motion passed unanimously.

- TLAD Think Like A Dog production crew wrapped up operations and vacated the Conference Center and Business Innovation Center. Jerry thanked Scott Rojas for overseeing their needs and use of the JEDCO facilities.
- Manufacturing Australia Tours Ben Eade, Executive Director of Manufacturing Australia, came to the USA in mid-June to tour manufacturing facilities in Louisiana, DC, and California. Since Incitec Pivot is founding member of Manufacturing Australia, touring the Incitec Pivot plant in Jefferson



- Parish (Dyno Nobel) was a priority. JEDCO facilitated a meeting with LED and GNO, Inc., and arranged site tours of the Dyno Nobel and Laitram Introlox facilities.
- Targeted Ad Campaigns JEDCO launched a digital/radio ad campaign to promote the SBA 504 loan program to small business owners. Because of the ad campaign, traffic to the JEDCO website has increased significantly.
