I. Call to Order - Chairman, Jimmy Baum

- Approval of Board absences Lloyd Clark motioned to excuse the above named absences, seconded by Mario Bazile. The motion passed unanimously.
- Approval of JEDCO minutes for March 22, 2018 Mario Bazile motioned to approve the minutes, seconded by Tom Gennaro. The motion passed unanimously.

III. Unfinished and New Business

 Resolution authorizing the Amendment to the Escrow Agreement between JEDCO, LCTCS Facilities Corporation and the State of Louisiana for the use and benefit of the Louisiana Community & Technical College System, Delgado Community College – Lacey Bordelon

Larry Katz motioned to approve the resolution authorizing an amendment, which extends the escrow funds transfer date to April 1, 2019. The motion was seconded by Roy Gattuso and passed unanimously.



 Resolution authorizing preliminary approval to a proposal by US Foods for the development of a Payment-In-Lieu-of-Taxes arrangement – Lacey Bordelon

Mickal Adler motioned to approve the resolution: (1) grants preliminary approval to the development of a cooperative endeavor agreement providing for up to \$2.67 million of reimbursement incentives to the company for construction expenses related to the expansion project, (2) authorizes special counsel, Adams and Reese LLP, to perform the legal work associated with the agreements, (3) approves the engagement letter with Adams and Reese LLP, which commits the company to pay JEDCO's bond counsel fees associated with the agreement.

Lloyd Clark seconded the motion. The motion passed with the following vote: Yeas-7 Nays-0 Absent-3 Abstained-1 (Larry Katz)

 Unbudgeted expense for JEDCO office reconfiguration to accommodate new staff members – Scott Rojas

Roy Gattuso motioned to approve an unbudgeted expense of \$40,000 to create new office space using the Halumm system. Work is expected to be complete by July 2018. The motion was seconded by Tom Gennaro and passed unanimously.

 Unbudgeted expense for generator tower to meet OSHA requirements for lifting – Scott Rojas

As of 2018, OSHA will not allow a maintenance worker to hoist/carry consumables such as oil and other associated parts up a ladder. Roy Gattuso motioned to approve an unbudgeted expense of \$7,000 to install a lift-chain fall-box to move equipment between floors. The motion was seconded by Mickal Adler and passed unanimously.
