The SLFPA-W Board of Commissioners met at approximately 5:30 P.M. on Tuesday, May 8, 2018 in the Board Room at the SLFPA-W Office, 7001 River Road, Marrero, Louisiana.

Ms. Maclay led all in attendance in the Pledge of Allegiance.

Ms. Maclay called the public meeting to order and directed Mr. Burke to call the roll.

Commissioners in attendance were: Mr. Burke, Mr. Gaddy, Ms. Maclay, Mr. Thomas, Mr. Valent and Mr. Wilkinson. Mr. Julien was absent.

There were no public comments.

The following resolution was offered by Mr. Scott M. Burke and seconded by Mr. Kendall Gaddy.

RESOLUTION NO. 050818-01

A resolution declaring the results of a special tax election held on Saturday, April 28, 2018, approving a *procès verbal* and proclamation of the canvass of the votes cast in said election and other matters in connection therewith.

WHEREAS, the Board of Commissioners of the Southeast Louisiana Flood Protection Authority-West (the "Governing Authority") as the governing authority of the West Jefferson Levee District (the "District") desires to, in open and public session pursuant to LSA-R.S. 18:1292, declare the results of a special election held on Saturday, April 28, 2018 relative to the authorization of a special ad valorem tax of four and three-quarters (4.75) mills on all property subject to taxation within the District for ten (10) years beginning in the year 2018 and ending with the year 2027, pursuant to Title 18, Chapter 6-A of the Louisiana Revised Statutes of 1950, as amended, for the purposes of constructing and maintaining necessary levees, levee drainage, flood protection, hurricane and flood protection projects; and

WHEREAS, the Governing Authority desires to approve a *Procès Verbal* and proclamation of the canvass of the votes cast in the above described special election held in the District on Saturday, April 28, 2018, which is attached hereto; and

WHEREAS, the Governing Authority desires to promulgate the results of the special election held on Saturday, April 28, 2018 in the District by publishing the *Procès Verbal* and proclamation in accordance with LSA-R.S. 18:1293; and

WHEREAS, the Governing Authority desires to forward a copy of the *Procès Verbal* and the proclamation to the Louisiana Secretary of State and the Clerk of Court for Jefferson Parish for recordation once executed as required by LSA-R.S. 18:1293 in the Mortgage Records of Jefferson Parish and in the Records of the Louisiana Secretary of State.

BE IT RESOLVED by the Board of Commissioners of the Southeast Louisiana Flood Protection Authority - West, acting as the governing authority of the West Jefferson Levee District, that:

SECTION 1. <u>Canvass.</u> This Governing Authority does now proceed in open public session to examine the official tabulations of votes cast at the special election held in the District on SATURDAY, APRIL 28, 2018, to authorize a special tax therein, and said Governing Authority does further proceed to examine and canvass the returns and declare the result of the special election.

SECTION 2. <u>Procès Verbal.</u> A <u>Procès Verbal</u> of the canvass of the returns of said election shall be made and a certified copy thereof shall be forwarded to the Secretary of State, Baton Rouge, Louisiana, who shall record the same in his office; another certified copy thereof shall be forwarded to the Clerk of Court and Ex-Officio Recorder of Mortgages in and for the Parish of Jefferson, who shall record the same in the Mortgage Records of said Parish; and another copy thereof shall be retained in the archives of this Governing Authority.

SECTION 3. <u>Promulgation.</u> The result of said election shall be promulgated by publication in the manner provided by law.

BE IT KNOWN AND REMEMBERED that on Tuesday, May 8, 2018, at 5:30 p.m., at the regular meeting place of the West Jefferson Levee District, 7001 River Road, Marrero, Louisiana, the Board of Commissioners of the Southeast Louisiana Flood Protection Authority - West (the "Governing Authority"), acting as the governing authority of the West Jefferson Levee District (the "District"), and being the authority ordering the special election held therein on Saturday, April 28, 2018, with the following members present:

did, in open and public session, examine the official certified tabulations of votes cast at the said election, and did examine and canvass the returns of the said election, there having been submitted at said election the following proposition, to wit:

PROPOSITION (MILLAGE)

Shall the West Jefferson Levee District (the "District") be authorized to levy and collect annually a special tax of 4.75 mills on all property subject to taxation in said District (the "Tax") (an estimated \$4,750,000 reasonably expected at the time to be collected for an entire year) for a period of ten years beginning with the year 2018, and ending with the year 2027; and shall the revenues or proceeds of 4.75 mills of the Tax hereafter received from the authorization of the Tax be dedicated and used for the purpose of constructing, raising, armoring and maintaining levees, and for the Repair, Rehabilitation and Replacement of capital projects for purposes of flood and hurricane protection including the Bayou Segnette Complex, Harvey Sector Gate Complex and the District's share of the West Closure Complex; including payments required in connection with debt obligations incurred for any of the above capital projects?
