Regular Meeting Minutes February 3, 2021 Revised 5/18/2021

President Anthony Alford called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the TLCD office located at 220 Clendenning Road, Houma, Louisiana, at 6:00 P.M. on February 3, 2021. The meeting was available for call in via teleconference.

Angela Hidalgo led the opening prayer and Commissioner Leward Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Mrs. Hidalgo, Commissioners recorded as present: Alford, Cenac, Chauvin, Davis, Henry, Moore, Walker, and Williams.

President Alford recognized the family of Walton "Buddy" Daisy as present in the meeting.

Mr. Dupre asked that item 8(a) be handled at this time.

Mrs. Hidalgo read into the minutes Memorial Resolution No. 21-002 in honor of TLCD Commissioner Walton "Buddy" Daisy. The resolution honors Commissioner Daisy by renaming the Lower Bayou Dularge Floodgate to the Lower Bayou Dularge "Buddy" Daisy Floodgate. There was a motion by Commissioner Henry, with a unanimous second, to pass Resolution No. 21-002. The motion passed.

President Alford and Executive Director Reggie Dupre presented the family of Commissioner Daisy with the Memorial Resolution.

Under approval of minutes, there was a motion by Commissioner Henry, seconded by Commissioner Chauvin, to approve the Regular Minutes dated January 20, 2021. The motion passed.

President Alford recognized Dirk Guidry, Danny Babin, and Sheriff Tim Soignet as present.

Under Public, there was nothing to report.

Under Management's Report, there was nothing to report.

Under Finance Committee Matters, Chairman Jack Moore asked the board to approve APTIM Invoice 514296 (HNC066) in the amount of \$105,518.08 for the HNC Lock Complex Project. Motion: Walker, Second: Chauvin. The motion passed.

Mr. Moore asked the board to approve the operating and engineering invoices as presented. Motion: Chauvin, Second: Williams. The motion passed.

Under Executive Director's Report, Mr. Dupre asked the board to authorize a Cooperative Endeavor Agreement with the Terrebonne Parish Sheriff's Office for law enforcement services for TLCD. The TLCD will pay 30% of the Deputy's salary (Dakota Fitch) and reimburse the Sheriff's office 50% of the cost of the vehicle, with an estimated annual cost of \$18,000.00. There was a motion by Commissioner Chauvin, with a second by Commissioner Moore, to approve the CEA. The motion passed.

Sheriff Soignet addressed the board regarding the Cooperative Endeavor Agreement.

There was a motion by Commissioner Walker, with a second by Commissioner Henry, to enter in Executive Session pursuant to La. R.S. 42:17(10) and La. R.S. 42:17(2) to discuss matters privileged under La. C.E. Art. 506 and/or to conduct strategy sessions in connection with the following pending or potential litigation: Kathleen Powell, et al, vs. State of Louisiana, et al, No. 129068, 32nd JDC, Terrebonne Parish, Louisiana; and to address Formal Written Demand received from Pontchartrain Partners, LLC concerning the contract for the MTG Hurricane Protection Interim Food Risk Reduction Project Falgout Canal South Levee tie-in and borrow/storage area. A roll call vote was called for on the motion. The vote there was as follows: Yeas: Alford, Cenac, Chauvin, Davis, Henry, Moore, Walker, and Williams. Nays: None. Absent and or not voting: None. The motion passed.

Motion: Walker, Second: Henry, to return to Regular Session. The motion passed.

There was a motion by Commissioner Moore, seconded by Commissioner Henry, by the passing of Resolution 21-003, to authorize Administration to make a request to the State Attorney General's office to approve the hiring of special counsel Loulan Pitre in conjunction with TLCD general counsel for the Kathleen Powell, et al, No. 129068. The motion passed.

Program Manager Mitch Marmande gave a slide presentation summarizing 2020 Emergency Events for TLCD.

Under Engineering Reports, Nicole Cutforth with APTIM provided an update on the HNC Lock Complex Project. Kevin DeZarn with APTIM provided updates on the Falgout Canal South Levee Tie-In, Falgout Canal North Levee Tie-in, Reach B Levee Alignment, and Bayou Lacache Projects.

Laura Barnes with GIS Engineering provided updates on Bayou Black Levee Alignment, Reach A Levee Alignment, Minor's Canal Floodgate, and the Grand Bayou Flood Control Structure Projects.

Stevie Smith with All South Consulting Engineers provided the board with updates on Reach K & L (South Lafourche Levee District Project), Lower Dularge Levee Rehab, and Lower Dularge Levee West Project.

Mr. Smith asked the board to approve Change Order No. 8 for Low Land Construction in the amount of \$286,310.00 for work on the Lower Dularge Levee East Rehabilitation Project. Motion: Chauvin, Second: Henry. The motion passed.

Mr. Smith asked the board to approve Change Order No. 5 for Low Land Construction in the amount of \$352,500.00 for work on the Lower Dularge Levee East Rehabilitation Project – Indefinite Embankment Supply contract. Motion: Henry, Second: Walker. The motion passed.

Under Program Manager's Report, Mr. Marmande asked the board to approve GIS' Professional Services Agreement for General Engineering and Consulting for year 2021, with a not to exceed of

\$50,000.00 on a "as needed" basis, and subject to review and approval by Program Manager. Motion: Henry, Second: Chauvin. The motion passed.

Mr. Marmande asked the board to authorize the amending of All South's Engineering Agreement for Lower Dularge West to accomplish the Bayou Crossing for moving dirt, with a not to exceed amount of \$190,379.30, pending review and approval by Program Manager. Motion: Moore, Second: Cenac. The motion passed.

Under Other Engineering Matters, there was nothing to report.

Under President's Report, there was nothing to report.

There being no further business to come before the board, it was moved by Commissioner Henry, with a second by Commissioner Moore, to adjourn the February 3, 2021 Regular Meeting of the Terrebonne Levee and Conservation District at 7:30 P.M. The motion passed.
