

# TERREBONNE LEVEE & CONSERVATION DISTRICT



### Regular Meeting Minutes January 19, 2022

President Anthony Alford called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the Terrebonne Levee & Conservation District Office located at 220 Clendenning Road, Houma, Louisiana, at 6:00 P.M. on January 19, 2022.

Angela Hidalgo led the opening prayer, and Commissioner Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Mrs. Hidalgo, Commissioners recorded as present are Alford, Cenac, Daisy, Davis, Henry, Moore, Walker, and Williams. Commissioner Chauvin is recorded as absent. Zoom function was unable to connect.

Under approval of minutes: Motion: Henry, Second: Walker, to approve the Regular Minutes dated January 10, 2022. The motion passed without objection.

Under Public, there was no one wishing to address the board.

Under Management's Report, Greg Gautreaux had nothing to report.

Under Finance Committee Matters, Mrs. Hidalgo presented the Financial Reports FME 31 December 2021. Motion: Henry, Second: Davis, to accept the Financial Report, as presented. The motion passed without objection.

Motion: Henry, Second: Moore, to return to regular session.

There was a motion by Commissioner Moore, seconded by Commissioner Walker, to pass *Resolution No. 22-007* authorizing TLCD's special legal counsel to accept the tender from Louisiana CPRA dated January 18, 2022. The motion passed without objection.

Jay Duplantis with All South Consultants, LLC provided updates on the Reach K & L Project, Lower Dularge Levee East Rehabilitation, Lower Dularge East Indefinite Embankment Supply, and the Lower Dularge Levee West Improvements Phase 3 Projects.

Philip Chauvin with T. Baker Smith provided updates on the TLCD General Services Agreement, Marmande Canal Water Control Structure, and Reach I Projects.

David Boudreaux with Delta Coast Consultants, LLC reported on the HNC Lock Complex, and Mitigation and Maintenance/Rehabilitation Projects.

# A RESOLUTION ACCEPTING CPRA'S TENDER OF DEFENSE IN THE POWELL AND AUCOIN LITIGATION

WHEREAS, Terrebonne Levee & Conservation District ("TLCD") and Coastal Protection and Restoration Authority ("CPRA") have been named as defendants in the following litigation: Kathleen Powell, et al. vs. State of Louisiana through the Terrebonne Levee & Conservation District, Terrebonne Parish Consolidated Government and Coastal Protection and Restoration Authority, No. 129068, 32nd JDC, Terrebonne Parish, Louisiana (the "Powell Litigation") and Dewey F. Aucoin and Lisa R. Aucoin. vs. State of Louisiana through the Terrebonne Levee & Conservation District and Coastal Protection and Restoration Authority, No. 191674, 32nd JDC, Terrebonne Parish, Louisiana (the "Aucoin Litigation");

WHEREAS, TLCD and CPRA are parties to a certain Intergovernmental Agreement effective as of July 1, 2010, in which CPRA agreed to provide certain funding to be used by TLCD, as Sponsor of The Morganza to the Gulf of Mexico Hurricane Protection Project, subject to the terms and conditions of that agreement (the "Intergovernmental Agreement");

WHEREAS, by letter dated January 13, 2022 and transmitted by email on January 18, 2022, CPRA has tendered to TLCD the defense of the Powell Litigation and the Aucoin Litigation in accordance with the terms of the Intergovernmental Agreement;

WHEREAS, TLCD has employed Loulan J. Pitre and the Kelly Hart Pitre Law Firm ("Special Legal Counsel") as special legal counsel to provide a defense in the Powell Litigation and the Aucoin Litigation; and

WHEREAS, TLCD would like to accept the tender by CPRA, to authorize its Special Legal Counsel to communicate to CPRA this acceptance of the tender, and to authorize its Special Legal Counsel to take appropriate steps to enroll as counsel for CPRA and provide such defense.

**NOW THEREFORE BE IT RESOLVED** by the Board of Commissioners of the Terrebonne Levee & Conservation District that TLCD accepts the tender contained in CPRA's letter dated January 13, 2022 and transmitted by email on January 18, 2022 by CPRA to TLCD of the defense of the Powell Litigation and the Aucoin Litigation in accordance with the terms of the Intergovernmental Agreement effective as of July 1, 2010, authorizes TLCD's Special Legal Counsel to communicate to CPRA this acceptance of the tender, and authorizes its Special Legal Counsel to take appropriate steps to enroll as counsel for CPRA and provide such defense.
