Regular Meeting Minutes June 2, 2021

President Anthony Alford called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the TLCD office located at 220 Clendenning Road, Houma, Louisiana, at 6:00 P.M. on June 2, 2021. The meeting was available via Zoom.

Angela Hidalgo led the opening prayer and Commissioner Leward Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Mrs. Hidalgo, Commissioners recorded as present: Alford, Chauvin, Davis, Henry, Moore, Walker, and Williams. Commissioner Cenac as absent. Reggie Dupre attended via Zoom.

Under approval of minutes, there was a motion by Commissioner Henry, seconded by Commissioner Chauvin, to approve the Regular Minutes dated May 19, 2021. The motion passed.

Under Public, there was no one wishing to address the board.

Under Management's Report, Greg Gautreaux provided an update on repairs and operation of the Cocodrie barge.

Under Finance Committee Matters, Chairman Moore asked Ed Daigle with USI Insurance to provide the quote for premiums for Worker's Compensation, Contractor's Equipment, Hull/P&I, and Pollution policies for 2021-2022, in the amount of \$121,062.64.
