## Regular Meeting Minutes November 17, 2021

President Anthony Alford called to order the Regular Meeting of the Terrebonne Levee and Conservation District at the Terrebonne Port Commission Office located at 1116 Bayou LaCarpe Road, Houma, Louisiana, at NOON on November 17, 2021.

Angela Hidalgo led the opening prayer, and Commissioner Henry led the Pledge of Allegiance to the American Flag.

Upon roll call by Mrs. Hidalgo, Commissioners recorded as present are Alford, Cenac, Chauvin, Daisy, Davis, Henry, Moore, Walker, and Williams.

Under approval of minutes: Motion: Henry, Second: Daisy, to approve the Regular Minutes dated November 3, 2021. The motion passed without objection.

Under Public, there was no one wishing to address the board.

Under Management's Report, there was nothing to report.

Mrs. Hidalgo presented the board with further information on TLCD office repairs.

Executive Director Reggie Dupre discussed Hurricane Ida issues. Laura Barnes with GIS Engineering provided further information on scheduled repairs to the HNC Floodgate.

Under Planning & Projects, Stevie Smith with All South Consultants, LLC provided updates on the Reach K & L Project, Lower Dularge Levee East Rehab, and the Lower Dularge Levee West Projects.
