- Dr. DiCarlo requested approval of the minutes from the February 24, 2022 Board meeting.

Dr. DiCarlo called for the Finance Report.

Ms. Goodson stated the Finance Committee met prior to the Board Meeting but due to a lack of quorum there are no recommendations for Board approval. Mr. Graffagnini reported there are two supplemental budget requests for discussion and approval by the Board. The first is the single Director recruitment fees for a total request of

\$269,615. The next budget request of \$175,381 for the Institutional Advancement & External Engagement was discussed. The details for the budget requests were provided in the reports.

A motion was made by Dr. Hamm and seconded by Dr. D'Amour.

RESOLVED, with all in favor, to approve the supplemental budget requests, as presented; Single Director Recruitment budget totaling \$269,615. Institutional Advancement & External Relations budget totaling \$175,381.

Ms. Reeder reminded the Board that in previous years the agreement with LPHI to oversee the TFL program was a multi-year agreement with automatic renewals. She added last year the Board opted for a one-year agreement with the option to renew. This option requires Board approval for a one year renewal.

A motion was made by **Ms. Goodson** and seconded by **Dr. Hamm.**RESOLVED, with all in favor, to extend the agreement with LPHI for an additional year.

Dr. DiCarlo called for an Executive Session.

Dr. DiCarlo called the meeting back to order following the Executive Session.

A motion was made by Dr. Hamm and seconded by Ms. Goodson.

RESOLVED, with all in favor, to move forward with haste in offering Dr. Joe Ramos the LCRC Director position, as recommended by the LCRC Search Committee.
