Also, in attendance were Paul V. Gonzales, CFO of Hummer, LLC; Joseph M. Taylor of Taylor Made Ambulance; Jeffrie Schultis of Greater New Orleans New Car Dealers Association; Dan Casey and Henry Casey of Casey & Casey Auto Title; and Commission staff: Ingya Cattle, Assistant Executive Director; Art Quick, Administrative Supervisor; and Commission Investigators, Bill Horaist, Perry Sponge, Joel Aguilard, Wayne Lee, and Amy Lawson.

Chairman Brandt welcomed the new member, Joseph William "Bill" Westbrook, to the Commission. The Executive Director presented to Commissioner Westbrook Oath of Office form, which was administered and executed.

The Executive Director presented to the Commission Members correspondence from Mr. Jim Taylor, Chief Executive Office of Hummer, LLC, requesting waiver of the million-dollar bond pursuant to LSA-R.S. 32:1254D(6)(a) for Hummer, LLC. Additionally, the Executive Director advised the Commission Members Hummer is currently a line reflected on the manufacturer and distributor license of General Motors LLC.

"As you know, in connection with licensing Hummer, LLC ("Hummer") as a distributor in the State of Louisiana, RS 32:1254 (the "Licensing Statute") may require hummer to provide a surety bond, executed by Hummer as the principal, in the sum of \$1,000,000. Pursuant to the discretion granted to the Louisiana Motor Vehicle Commission ("the Commission"), please consider this letter our request that the Commission waive the \$1,000,000 bond requirement as it applies to Hummer for the reasons set forth below.

- 1 Hummer does not maintain an extensive dealership network in the State of Louisiana. We currently plan to maintain only three authorized franchise dealerships in Louisiana (*i.e.* Hummer of Metairie, ORR Cadillac Hummer (Shreveport) and Gerry Lane Hummer (Baton Rouge)).
- 2 Hummer sells a relatively small number of vehicles in Louisiana. In 2009, the previously listed dealerships collectively sold 191 Hummer vehicles, and our 2010 vehicle sales forecast does not project a substantial increase from 2009 levels.
- 3 The cost of providing a \$1,000,000 bond is disproportionate to the benefits gained from maintaining a dealer network in Louisiana. As a new entity, Hummer will be required to cash-collateralize the \$1,000,000.00 bond in its entirety. As a result, Hummer would be subject to a significant cash outlay. The associated cost to Hummer on a per-vehicle-sold basis may be prohibitive to maintaining Hummer dealers in Louisiana, and it is likely that Hummer would have to re-evaluate its decision to continue to maintain a distribution network in Louisiana if required to provide the \$1,000,000 bond.

As you know, Hummer has a unique connection with Louisiana as a result of the continued manufacture of

vehicles in Shreveport, and Hummer sincerely hopes to continue that connection and the associated success it has shared with Louisiana. Accordingly, we are committed to working with the Commission to reach an outcome satisfactory to all parties that would ensure the continued distribution of the Hummer brand in Louisiana.

We respectfully ask the Commission to waive the \$1,000,000 bond requirement set forth under the Licensing Statute. In addition, we welcome any suggestions the Commission may have with respect to an alternative resolution. The Executive Director introduced Paul Gonzales, Chief Financial Officer of Hummer LLC. Mr. Gonzales addressed the Commission Members regarding Hummer's sales and financial situation. Mr. Gonzales stated that General Motors LLC will manufacturer Hummer and cover Hummer's liability insurance and vehicles warranty till mid 2012. He continued to addressed to the Commission regarding a possible buy/sell between Hummer and a Chinese company wherein if the buy/sell went through, the new company would then file a new application and bond waiver request. After a brief discussion, Commissioner Hocesvar made a motion to grant the waiver of the bond, pursuant to LSA-R.S. 32:1254D(6)(a) for Hummer LLC until its license renewal in 2013. Commissioner Tarver seconded this motion and it was unanimously approved.

The Executive Director presented to the Commission Members correspondence from Joseph M. Taylor, Vice-President and General Manger of Taylor Made Ambulance, dated December 28, 2009, requesting waiver of the million-dollar bond pursuant to LSA-R.S. 32:1254D(6)(a):

"Taylor Made Ambulances respectfully requests that the \$1,000,000.00 surety bond requirement for the issuance of a converter or secondary manufacturer license be waived.

We are an ambulance converter located in Arkansas and have been in the ambulance conversion business for over 20 years. We anticipate selling less than 50 ambulances in the Sate of Louisiana each year and the cost of the surety bond would far outweigh the profit margin on those vehicles. The estimated bond premium would exceed \$50,000.00 per year.

We respectfully ask that our request for waiver be placed on the agenda for your next meeting on January 11, 2010. If we can be of further assistance, please do not hesitate to contact us at (800) 468-1310."

At this time, the Chairman opened the floor for Joseph M. Taylor, Vice-President and General Manger of Taylor Made Ambulance to addressed the Commission Members regarding Taylor Made Ambulance's financial report. Mr. Taylor answered the questions of the Commission Members. After a brief discussion, the Chairman deferred Taylor Made Ambulance's bond waiver request until such time as Taylor Made Ambulance submits documentation and information reflecting an improved financial condition.

The Executive Director presented to the Commission Members correspondence dated January 6, 2010, from Jeffrie Schultis Fricke, Assistant Executive Director of the Greater New Orleans New Car Dealers Association:

"Please consider this a formal request by the Greater New Orleans New Car Dealers Association for authorization to sponsor a public Auto Show. This letter includes the particulars of the event.

- ◆ Name 27th Annual Greater New Orleans International Auto Show
- ◆ Dates March 12 - 14, 2010, Friday, Saturday, Sunday
- ◆ Location Morial Convention Center - New Orleans
- ◆ Dealers Only new motor vehicle franchised, licensed dealers will exhibit motor vehicles at this event

Under consideration non selling and selling;

If Selling Show - Friday and Saturday only. Sunday open non selling

If Non Selling Show -

Friday and Saturday will be staffed by licensed dealership sales people answering consumers questions, setting appointments and passing out dealership business cards as in the past.

Sunday will not be staffed by licensed dealership salespeople. Manufacturers reps, dealership managers, temporary product specialists hired by either the manufacturer or the dealership will staff the auto show. It will be written in the auto show contract, that no licensed sales people other than management will be allowed to staff the exhibit space on Sunday.

Normal manufacturers' auto show literature and materials will be available on all three days.

A list of participating dealers will follow. Please let me know if there is anything else you need to process this request at your next meeting."

At this time, the Chairman opened the floor for Jeffrie Schultis Fricke to address the Commission. Ms. Fricke advised the Commission Members the 27th Annual Greater New Orleans International Auto Show be a selling show for Friday and Saturday and Sunday would be display only with no licensed salespersons at the show. Ms. Fricke stated there would be no test drives at the show on Sunday if a selling show. Ms. Fricke continued by stating they would not be sure whether it would be a selling or non selling show until the end of January or beginning of February and inquired if the Commission would allow Pre-owned Vehicles, RV's, Motorcycles, and Boats at the show. The Commission advised Ms. Fricke Pre-owned Vehicles would not be allowed and in order to have RV's Motorcycles, and Boats at the show she would have to be licensed as a trade show promoter and different rules and requirements regarding RV's, Motorcycles, and Boats. Ms. Fricke withdrew the request regarding RV's, Motorcycles, and Boats. A lengthy discussion ensued after which, Commissioner LeBlanc made a motion to approve the 27th Annual Greater New Orleans International Auto Show as a selling show for Friday and Saturday only, conditioned upon the Law and the Rules and Regulations promulgated by the Commission being strictly adhered to. Commissioner Tarver seconded. This motion was approved by a majority vote, Commissioners Corley and Commissioner Guidry voted nay.

After the discussion at the December meeting of "Canceled/Rescinded Sales Of Motor Vehicles", the Executive Director invited Dan Casey and Henry Casey to this meeting to answer any questions the Commissioners may have and provide information regarding this topic. The Casey's presented the following policy the Louisiana Department of Public Safety, Office of Motor Vehicles, which had been posted today as the new policy:

CANCELED/RESCINDED SALES OF MOTOR VEHICLES

POLICY:

DEFINITION

A new vehicle is defined as a motor vehicle, recreational product, or specialty vehicle, the legal title to which has never been transferred by a manufacturer, distributor or dealer to an ultimate purchaser. Therefore, a sale will only be considered **CANCELED** when a **NEW** vehicle is sold, however, the incorrect Manufacturers Statement of Origin (MSO) or Certificate of Origin (CO) was submitted in error with the title file and the other vehicle is still on the lot and has not been sold.

Example: ABC Dealership received a red and a blue 2010 LL, same make and model. The MSO (or CO) for the blue LL was submitted in error with the title file for the red LL. If the blue LL is still on the dealer's lot, the sale can be canceled on the red LL.

A used vehicle is defined as a motor vehicle, recreational product, or specialty vehicle, the legal title of which has been transferred by a manufacturer, distributor or dealer to an ultimate purchaser. Therefore, a sale can be **RESCINDED** when a vehicle is sold and the dealer or individual agrees to retake possession of the vehicle. A rescinded sale vehicle must be processed as a used vehicle upon reassignment of the title.

REQUIREMENTS:

All requests to cancel or rescind the sale on a motor vehicle must be directed to the Office of Motor Vehicles, Headquarters Administration, P.O. Box 64886, Baton Rouge, Louisiana, 70896-4886.

Items Required to Cancel a Sale

- A notarized affidavit from the dealer, including a complete description of the vehicle and an explanation for the request.
- The correct MSO/CO must be submitted with all assignments and sale/odometer information.
- The sale will be canceled only after the correct sale has been processed.
- If both vehicles have been sold and titled, title corrections will be processed for both vehicles.

Items Required to Process a Rescinded Sale - Individual to Individual

- The properly assigned certificate of title reassigning the vehicle back to the original owner (including the current odometer disclosure), registration and license plate.
- A notarized affidavit from the original owner containing a complete description of the vehicle, stating he has accepted the vehicle back and refunded the new owner his purchase price.
- A notarized affidavit from the new owner containing a complete description of the vehicle, stating that the vehicle was returned to the original owner and that the original owner did in fact refund the purchase price. A refund request for sales tax only can be submitted at the same time.
- \$26.50 title and registration fee.
- The appropriate license plate fee, if needed.

Items Required to Process a Rescinded Sale - Dealer to Individual

- The certificate of title, registration and license plate.
- The lien release, if applicable.
- A notarized affidavit from the dealer containing a complete description of the vehicle, stating he has accepted the vehicle back and refunded the buyer his purchase price. The statement must include an explanation of why the vehicle was returned.
- A notarized affidavit from the buyer containing a complete description of the vehicle, stating that the vehicle was returned to the dealer and that the dealer did in fact refund the purchase price and sales tax. Title, registration and license plate fees will not be refunded. Only sales tax will be refunded.
- Option #1 - the dealer can reassign the title in his name for resale purposes only. The \$26.50 title and registration fee must be submitted with the file.
- Option #2 - the dealer can reassign the title for resale purposes only. A copy of the reassigned title must be included with the file.

COMPLETELY REVISED

PROCEDURE:

For canceled sales - The SC CP flags will be updated on the vehicle master record to indicate a cancellation has been processed. All SC CP flags require approval by an OMV administrator.

For rescinded sales - An RS CP flag will be updated on the vehicle master record to indicate that a rescinded sale has been processed. These flags will remain protected on the vehicle record and will automatically be lifted when the appropriate title transaction is processed. However, the flag(s) will remain on the record when processing a TT61, TT62, LA or VA.

RS CP flag - TT24, TT25, TT28, TT35, TT57, and TT59 are allowed."

A discussion ensued during which the Caseys responded to the Commissions questions. The Chairman thanked the Caseys for their time and expertise.

The Executive Director presented to the Commission Members correspondence dated January 5, 2010, from Sherry Bourg of Don Bohn Ford:

After a brief discussion, Commissioner Corley made a motion to approve the auto display conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request letter of January 5, 2010, remaining constant. Commissioner Hargroder seconded this motion and it was unanimously approved.

At this time the Executive Director advised the Commission Members, due to unforeseen legal expenses, i.e., legal issues regarding taking on the recreational products licensing and pre-hearings of recreational product dealers' complaint against their manufacturers, Counselor Reggie had exceeded the limits of the contract and requested the following amendment to the contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed \$130,000.00 for the period commencing February 1, 2009 and ending on January 31, 2010." After a brief discussion, Commissioner Hargroder made a motion to approve the amendments to Counselor Reggie's current contract. Commissioner Corley seconded this motion and it was unanimously approved




