MINUTES OF THE MEETING OF THE

The meeting was called to order at 10:15 a.m. by Chairman Raymond J. Brandt.

The Executive Director presented to the Commission Members facsimile request from consumer, Betty J. Vardin, dated December 11, 2010, to be placed on agenda:

"I, Betty J. Vardin, is requesting to get onto the list for the next Monthly meeting on Jan. 10, 2011. I would like to address the Commission at this time."

The Chairman noted Ms. Vardin was not in attendance. The Executive Director briefly explained to the Commission Members that Ms. Vardin was a consumer who had a complaint against Premier Jefferson Asian Imports, L.L.C. DBA Premier Kia of Kenner and had wished to address the Commission.

The Executive Director presented to the Commission Members correspondence from Roy M. D'Aquila, attorney for Deep South Fire Trucks, Inc., dated December 17, 2010, requesting waiver of the million-dollar bond pursuant to LSA-R.S. 32:1254D(6)(a).

"Deep South Fire Trucks, Inc. is licensed as a Converter and Secondary Manufacturer. On June 14, 2010, we appeared before the Louisiana Motor Vehicle Commission and the \$1,000,000.00 Bond was waived.

We are hereby requesting a waiver of the \$1,000,000.00 Surety Bond required of a Converter or a Secondary Manufacturer for the year 2011. We ask that you place us on the agenda for the January 10, 2011 meeting of the Louisiana Motor Vehicle Commission in order that the Commission can consider this request.

Thank you for your anticipated cooperation. If any additional information or documentation is required, please contact me."

At this time, the Chairman opened the floor for Roy D'Aquila, Esq., Richard Ellis, Owner and Charles Barber, Owner to addressed the Commission Members regarding Deep South Fire Trucks' sales and financial situation. After reviewing their Balance Sheet and Profit & Loss Report, the Chairman questioned Deep South Fire Trucks' financial

situation which was not improved from last year. After a brief discussion, Commissioner Hocever made a motion to waive the bond requirement for one month allowing Deep South Fire Trucks to compile a more detail financial statement for the Chairman to review and to give the Chairman the authority to make a determination whether to grant the waiver of the bond, pursuant to LSA-R.S. 32:1254D(6)(a) for Deep South Fire Trucks, Inc. Commissioner Hargroder seconded this motion and it was unanimously approved.

At this time, Commissioner LeBlanc made a suggestion to raise the surety bond amount and/or other means of protecting the consumers of Louisiana with regard to lien payoffs and sales taxes, tiles, and registration when buying a vehicle. After a lengthy discussion, the Executive Director was directed to forward to Commissioner LeBlanc statutes from other states who utilize a recovery fund instead of a surety bond. After a brief discussion, the Chairman appointed a study group, Commissioner Hargroder, Commissioner LeBlanc and Commissioner Bent, to review the various statutes and formulate any recommendations for statutory change with regard to the mandated surety bonds.

The Executive Director presented to the Commission Members correspondence received on December 20, 2010 from Glen Fritscher, General Manager of Acadiana Dodge, Inc.:

"Deep South Fire Trucks, Inc. is licensed as a Converter and Secondary Manufacturer. On June 14, 2010, we appeared before the Louisiana Motor Vehicle Commission and the \$1,000,000.00 Bond was waived.

We are hereby requesting a waiver of the \$1,000,000.00 Surety Bond required of a Converter or a Secondary Manufacturer for the year 2011.
