On a motion by Committee Member Brandon O. Williams and seconded by Board Member Willie M. Robinson, the Minutes of the September 13, 2022 LHC BOD Programs Committee Meeting were unanimously approved, as distributed.

Next item discussed was regarding the Developer Assistance Plan ("DAP").

The matter was introduced by Secretary Brooks.

Additional information being provided by LHC Executive Director Joshua G. Hollins, noting that he had been in dialogue with the Governor's Office to use \$5.8M of ERAP2 funds and \$10M in HOME ARP funds to further the initiative.

ED Hollins noted that the funding gaps needs far exceed the resources currently available.

Next item discussed was regarding the RFP for Program Management of Disaster Response and Recovery Housing Programs.

The matter was introduced by Secretary Brooks.

Additional information being provided by ED Hollins, briefly noting the process and scoring parameters, as well as the scheduled oral interviews of the five (5) finalist applicants.

Robinson and seconded by Board Member Willie Rack, the resolution to approve and authorize the Louisiana Housing Corporation ("Corporation") to select and contract with the highest scoring proposer(s) to the Request for Proposals for Program Management of Disaster Response and Recovery Housing Programs; and providing for other matters in connection with the foregoing; be submitted FAVORABLY to the Full Board at the October 19, 2022 BODM for approval.

Robinson and seconded by Board Member Ericka McIntyre, the resolution of intention to issue not exceeding Three Million, Two Hundred Fifty Thousand Dollars (\$3,250,000) Multifamily Housing Revenue Bonds for Tangipahoa Homes located at 12714 Shady Groove Loop, Amite, Tangipahoa Parish, Louisiana, in one or more series to finance the acquisition, rehabilitation, construction, and equipping of a multifamily housing development within the State of Louisiana; to establish the maximum qualified basis and low-income housing credits to Tangipahoa Homes; to authorize the staff and counsel to prepare the forms of such documents and agreements as may be necessary to allocate 4% Low-Income Housing Tax Credits to such facilities; and providing for other matters in connection with the foregoing; be submitted FAVORABLY to the Full Board at the October 19, 2022 BODM for approval.
