**MINUTES OF THE  
LOUISIANA LANDSCAPE ARCHITECTS SELECTION BOARD  
AUGUST 31, 2004**

A meeting of the Louisiana Landscape Architectural Selection Board (LLASB) was held in the Claiborne Building, 1201 North Third Street Room 1-100, Baton Rouge, LA on Tuesday, August 31, 2004.

Mr. Jerry W. Jones called the meeting to order at 10:10a.m. Those members present were: Mr. Stephen Shurtz, Mr. Sadik Artunc, Mr. Wallace “Skip” Treme. Mr. Keith Bleichner, Mr. Rick McGimsey, Attorney General’s office as Legal Counsel.
