**Motion: Tumlin/LeBlanc:** To approve the license renewal application for Street Collaborative, LLC. **Passed. 7-0.**

**James R. Aultman - An Architectural Corporation**

Tumlin presented a Delinquent Firm License Renewal application from James R. Aultman, An Architectural Corporation, which indicated that it had practiced or offered to practice architecture in Louisiana without a firm license. Hillegas reported that the firm principal indicated that the license had gone delinquent following turnover of administrative staff in his office, and he was not aware that the firm's license had gone inactive.

**Motion: Cardone/Blicht:** To issue a consent order with a proposed penalty of \$2,400 and \$125 administrative fee. **Passed. 6-1.**

**Reciprocal Application with Disciplinary Action**

Hillegas presented a reciprocal application received from Byung Il Yoo that indicated that Mr. Yoo had signed a stipulation agreement with the Florida Board for Architects and Interior Design in May 2016 for unlicensed practice.


**Motion: Cardone/McKinney: To approve the reciprocal license application for Byung Il Yoo. Passed. 7-0.**

**Firm Renewal Application**


