

MINUTES OF THE MEETING OF THE LOUISIANA STATE BOARD OF ARCHITECTURAL EXAMINERS 9625 FENWAY AVE., STE B BATON ROUGE, LA 70809-1592 JULY 28, 2023, 10:00 A.M.

At 10:00 a.m. on July 28, 2023, Ronald B. Blitch called the meeting to order at the board's office in Baton Rouge, Louisiana, with the following members present:

President Blitch welcomed everyone to the meeting.

The members of the Complaint Review Committee who were involved with Case #2022-04 (Mr. Singh, Mr. Brossett, and Ms. Kobila) recused themselves and left the meeting; pursuant to notice, the remainder of the board participated in a formal hearing for Case #2022-04.

At 11:00 a.m., the board came back together, and members of the Complaint Review Committee who were involved with Case #2022-27 (Mr. Brossett, Ms. Kobila, and Mr. Holly) recused themselves and left the meeting; pursuant to notice, the remainder of the board participated in a formal hearing for Case #2022-27.

The board recessed at 11:50 a.m. and resumed at 12:20 p.m.

President Blitch welcomed everyone back to the meeting, then reviewed the agenda and recognized public comment time.

Minutes

The Board unanimously approved the motion by Mr. Holly, seconded by Ms. Kobila, to approve the minutes of the May 26, 2023 special board meeting and the minutes of the May 26, 2023 regular board meeting.

Legal Counsel Report

Rule §1907(E) amendment

Spaht reported that at its meeting in July of 2023 the Occupational Licensing Review Commission gave its initial approval to the proposed amendment to Rule §1907(E) concerning the General Disciplinary Guidelines concerning the fine for architectural firms practicing with an expired license. This initial approval allows the board to proceed with rule-making, including the publication of a Notice of Intent in the *Louisiana Register* and the filing of a Fiscal & Economic Impact Statement with the Legislative Fiscal Office.

Licensing Laws and Rules revision update

Spaht reported that the Licensing Laws & Rules Committee ("L&R") had met before the May board meeting and plans to meet again following the meeting today. The L&R is currently focusing on the licensing sections of the laws and rules.

Strategic Planning Review - LSBAE Self-Survey

Ducote reminded the board of the decision made at last year's strategic planning session for the board to complete an annual self-survey. Blitch led the discussion on the merits of completing this survey and the

time of year when it should be completed. It was decided to add an item to the September board meeting agenda for a deeper review of the 2023 survey results.

Complaint Review Committee Report

Brossett and Owens presented the report of the Complaint Review Committee ("CRC") consisting of Brossett, Kobila, and Singh.

<u>Case #2022-15</u> - Owens reported on a case involving a licensed professional architectural corporation which practiced and/or offered to practice architecture in Louisiana with an expired certificate of authority. The Respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. Respondent to pay a fine of \$1,500 and costs of \$471.84;
- 2. Publication of this disciplinary action on the board's website and a summary of this matter printed in the board's newsletter, both identifying Respondent by name, and
- 3. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

The Board unanimously approved the committee motion, seconded by Mr. Holly, with the CRC members abstaining, to accept the consent order as presented.

After the motion passed, the Respondent was identified as Border Architects, Inc.

Owens provided an update on current enforcement statistics noting that there were 17 open cases, 12 cases closed since the May meeting, 9 cases opened since the May meeting, 56 pending cases, and 6 letters of caution issued since the May meeting.

Ducote discussed a CRC motion to include the board's online Laws & Rules Quiz as a standard sanction item on all future proposed consent orders.

The Board unanimously approved the motion by Mr. Cardone, seconded by Mr. Singh with the CRC members abstaining, to include the Board's online Laws & Rules Quiz as a standard sanction item to be included in proposed consent orders, requiring that the respondent score a minimum of 80% on the quiz with no continuing education credit being awarded.

The Board unanimously approved the motion by Mr. Brossett, seconded by Mr. Singh, to approve the list of licenses and certificates issued for the period May 17, 2023, through July 21, 2023.

Ducote reported that he had not received the state data provided by NCARB on Louisiana architectural candidates and licensees since the May board meeting. He then reviewed and discussed the corrected data from the 2022 NCARB by the Numbers data, which had been initially reported as incorrect. The corrected data showed 40 ARE competitions in 2022, which brought Louisiana's pass rate to 56%, such rate above the national average of 55%.

Mr. Singh reported on the NCARB Licensing Advisor Summit, which he and Lindsy Stewart will attend in Kansas City, MO, in early August.

Executive Director's Report

Financials

Ducote reported on the end of the fiscal year financial numbers. The board ended the 2023 fiscal year with 109% of projected revenue, a 6% increase over 2022. This was primarily due to an increase in renewals and delinquent renewals. Expenses ended at approximately 85% of the projected amount, an increase of only 1% over 2022. Board expenses related to cyber insurance, board member travel, annual audit, and staff insurance were higher than expected.

July 2023 began with the completion of the firm renewal cycle with approximately 89% of the budgeted income having been received. He noted that any remaining income earned would come through initial, reciprocal, and reinstatement architect license applications and initial and reinstatement firm certificate applications.

CD investment

Ducote advised that he would begin the CD laddering project after the annual audit is complete, and he would have an update at the September meeting.

Louisiana Compliance Questionnaire

Ducote presented the annual Louisiana Compliance Questionnaire, which is required as part of the Legislative Auditor's audit of the board's records for the period ending June 30, 2023.

The Board unanimously approved the motion by Mr. Elberson, seconded by Ms. Kobila, to approve and adopt the completed 2023 Louisiana Compliance Questionnaire, as presented.

Stolen Mail Update

Ducote reported that the board recouped the \$4,000 stolen via the altered board check on July 14, 2023. The bank gave no information on the outcome of its investigation. Ducote reiterated that staff has begun using alternate payment methods to reduce the number of checks it mails.

FY2024 Budget

Ducote requested an amendment to the Legal Miscellaneous expense line in the FY24 budget for increased expenses due to the two formal hearings and the overlap in bringing in a new attorney to train with Paul prior to him leaving employment with the board.

The Board unanimously approved the motion by Mr. Cardone, seconded by Mr. Brossett, to amend the Legal Miscellaneous expense line in the FY24 budget from \$1,500 to \$30,000.

Louisiana Professional Engineering and Land Surveying Board (LAPELS)

Ducote reported that LAPELS has updated its portion of the "Information on Architecture and Engineering Licensure Laws and Rules in Louisiana" book and requested that LSBAE do the same so that an updated version may be released. Both boards co-authored the book 11 years ago. It was agreed that Ducote would let LAPELS know that a Laws and Rules Committee has been formed, and it is currently working through a refresh and language update. The board will let them know once we are completed.

Miscellaneous

The board discussed an issue confronting the Fire Marshal's office involving its hiring qualified architects due to how the Civil Service hiring language is written regarding the earning of experience. Ducote reported on a letter AIA New Orleans sent NCARB regarding the New Orleans PSI testing locations and their failure to follow NCARB testing protocol, Finally, Ducote gave an update on a meeting he attended since the May meeting.

Mr. Elberson left the meeting at 1:45 p.m.

Discussion Items

Louisiana Architects Selection Board Nominations

Ducote presented the candidates for Districts 1-5 for the 2023-2024 Louisiana Architects Selection Board ("LASB") to the board. No objections to the candidates were made.

The Board unanimously approved the motion by Mr. Brossett, seconded by Mr. Holly, to accept the nominations of the following individuals for election and service on the LASB from September 15, 2023, through September 14, 2024:

Executive Director's Annual Performance Review

The board discussed Ducote's updated annual performance review forms and timeline. It was agreed to do a dry run prior to the September meeting and discuss the next steps at that meeting.

LSBAE Substance Abuse and Drug-Free Workplace Policy

The board reviewed and discussed a substance abuse and drug-free workplace policy for staff.

The Board unanimously approved the motion by Mr. Holly, seconded by Ms. Kobila, to adopt the LSBAE Substance Abuse and Drug-Free Workplace Policy, as written.

September 2023 board meeting/AIA Louisiana Annual Conference

Ducote led a discussion of a request from AIA LA regarding the current agreement related to the new licensee awards dinner and celebration. The board then discussed the timing of and travel funding for the September LSBAE board meeting, which is being held in conjunction with the AIA Louisiana Annual Conference in New Orleans.

The Board unanimously approved the motion by Ms. Kobila, seconded by Mr. Singh, to approve travel funds to the September LSBAE Board Meeting and AIA Louisiana Annual Conference in New Orleans, LA, on September 28-29, 2023, for all board members and executive staff.
