LLC Graphic Artist Tiffany Goodyear will design the ticket. Ms. Hudson turned the floor over to Bonny Botts for a special presentation on the Lottery history and 20^{th} Anniversary campaign.

Rose then turned the meeting over to Karen Fournet for the financial report.
