This process would identify offenses that would be denied taking the NCLEX-PN exam upon course completion. When students seek admission into a PN program, they must submit criminal background checks and written narratives concerning the incident. They are notified that they may not be able to take NCLEX-PN exam upon completion of the course. Students do not take the seriousness of their previous actions. If they complete the program but the Louisiana State Board of Practical Nurse Examiners denies ability to take the test, they have lost valuable time, money and self-esteem. In some instances the students in PN programs are denied clinical experience by the nursing home or hospital. The advisory committee would be tasked with researching many sources of how to handle the admission process from prior criminal background as to what offenses would deny or delay admission into PN programs. This does not restrict the Louisiana State Board of Practical Nurse Examiners from denying the ability of any PN graduate from previous or present criminal offenses. The PN programs after Louisiana State Board of Practical Nurse Examiners approval would be notified in a timely manner for any changes made to admission criteria from the LSBPNE.
