- Operations Report for January 2021. The number of passengers transported in January was 1,166. The daily average was 48.58 riders. Average scheduled trips per hour was 1.22. Revenue collected was \$2,265 and 3 vouchers. There were 12,324 miles traveled at an average cost of \$7.19 per mile. Average miles per trip was 10.57. The ADA denial rate was 0%. The highest percentage of denials were in the 12:30-12:59pm time frame.
- L. Andrews presented the January 2021 Secretary/Treasurer's Report. Profit and Loss through January is \$80,654.59. Profit and Loss from inception through January 2021 shows a net loss of (\$233,623.72). Total Equity & Liabilities as of January 31, 2021 was \$295,568.20. The Statement of Cash Flows shows total cash as of January 31, 2021, and inception through January 31, 2021 to be \$165,862.23.
- C. Faucheux requested a motion approving the January 2121 Secretary/Treasurer's Report. It was moved by H. Banquer and seconded by S. Jasmin. Motion carried unanimously.
- L. Andrews listed the following checks for accounts payable: Solutient, Invoice No. 11686 (January Services), \$6,250, Check No. 2301; Transdev, Invoice No. 0101-2021 (January 2021 Services), \$89,651.76, Check No. 2302; L'Observateur, Invoice No. 190366/0221 (Oct-Dec Meeting Minutes), \$344.61, Check No. 2303; and Via Mobility Services, Invoice No. 001-2563 (Feasibility Study), \$45,000, Check No. 2304.
- C. Faucheux requested a motion for approval of the accounts payable. Approval of the accounts payable was moved by E. Broussard, III and seconded by R. Drexel. Motion carried unanimously.

No collateralization report was included in the packet as the funding did not meet the \$250,000 threshold in January.

G. Guter announced that P. Mizell was chosen for the pass program.

The 5:00-5:29am, 1:00-1:29pm, and 4:00-4:29pm were the peak service periods in January.

- S. Van Sickle reviewed the updated grant activity spreadsheet.
- G. Guter and C. Faucheux provided a summary of the Cityways presentation. G. Guter further stated that the project was entering the Beta testing stage, employees were getting trained today, and that the marketing strategy would involve Transdev's cooperate team.
- S. Van Sickle directed the board to the FY21 CRRSAA proposed line items. G. Guter discussed the barriers and sanitation system. Discussion ensued regarding the amounts in operations versus preventive maintenance. A. Thompson stated that she agreed with the breakout.
- C. Faucheux requested a motion for approval of the FY21 CRRSAA line items/amounts. Approval of the line items/amounts was moved by E. Broussard, III and seconded by H. Banquer. Motion carried unanimously.
- C. Faucheux read through Resolution No. 01-2021 authorizing the RPTA Board Chair to complete the FY21 Certifications and Assurances.
