She also asked about statistics for the website. S. Van Sickle reported that the website update is underway.

Operations Report for December 2020. The number of passengers transported in December was 1,288. The daily average was 49.5 riders. Average scheduled trips per hour was 1.22. Revenue collected was \$2,505.15 and 6 vouchers. There were 14,019 miles traveled at an average cost of \$6.77 per mile. Average miles per trip was 10.88. The ADA denial rate was 0%. The highest percentage of denials were in the 8:00-8:29am, 9:00-9:29am and 4:00-4:29pm time frames.

- L. Andrews presented the December 2020 Secretary/Treasurer's Report. Profit and Loss through December is (\$167,753.70). Profit and Loss from inception through December 2020 shows a net loss of (\$269,278.31). Total Equity & Liabilities as of December 31, 2020 was \$124,917.24. The Statement of Cash Flows shows total cash as of December 31, 2020, and inception through December 31, 2020 to be \$35,389.90.
- C. Faucheux requested a motion approving the December 2020 Secretary/Treasurer's Report. It was moved by H. Banquer and seconded by E. Broussard, III. Motion carried unanimously.

- S. Van Sickle directed the board to the FY21 CRRSAA apportionment letter from the NORPC.
- S. Van Sickle informed the board that she would contact them with possible dates/times for the Cityways technology presentation.

Via presented the RPTA Feasibility Analysis Final Report.

The next meeting was proposed for February 11, 2021.

C. Faucheux requested a motion to adjourn. Approval to adjourn was moved by H. Banquer and seconded by S. Jasmin. Motion carried unanimously.

Having no more business to discuss, the meeting was adjourned at approximately 11:45am.
