He's only showing that he's worked there since 11-7-16 to current, but Terry works for a sister company of LandWorks, Incorporated, and he has actually been in and out of the landfill for, I'm going to say, five or six years. He's come in on final summer projects and done a lot. He's been there a whole lot more than what that eleven months reflects.

So, I really would like for this application to be resubmitted. However, the circumstances are LandWorks only has one Level B, other than the supervisor, and that one guy is having to work every Saturday because -- in order to have a certified operator there.

So, if the Board -- Terry has not tested, but if the Board could issue a conditional so that we could actually have a certificate on the wall and keep this one guy from having to work every Saturday until March and, hopefully, Terry will test prior to March.

MR. LAGRANGE: He'll submit another application for consideration in March for a regular certificate.

MR. BARBER: Right.

MR. LAGRANGE: Yeah. He's got the two years construction experience and one year solid waste experience, but this is a conditional right here.

CHAIRMAN: Actually, it's the same situation we just had with Mr. Stelly where, you know, he qualifies but he wants
