At this time of the Public Meeting, the Chairman called for any public comment regarding the Agenda. There was no comment.

Upon motion by Mr. Libersat and seconded by Mr. Thibodeaux, the minutes of the previous meeting of January 27, 2020 were accepted and approved. Motion carried.

Sellers and Associates gave an update on the Siphon project reporting the project is complete.

Sellers and Associates gave an update on the Conveyance Channel Control Structure South Gate and Well Rehabilitation recommending Teche-Vermilion Fresh Water District to insure the gate which is at the Pump Station.

Upon motion by Mr. Libersat and seconded by Mr. Segura, the Board approved partial payment #1 from McInnis Brothers Construction, Inc. in the amount of \$110,762.10 which includes 35% of mobilization cost. Motion carried.

Sellers and Associates gave an update on opening of the Loreauville Canal Bypass Channel reporting once the Excavation estimate is received the preliminary Budget will be prepared.

Gene Sellers, Jr gave an update on the New Office Building reporting 90% of the plans are complete. He also recommended Teche-Vermilion Fresh Water District grant Slemco an underground electrical easement of 10' x 295'.

Upon motion by Mr. Thibodeaux and seconded by Mr. Libersat, granting Slemco underground electrical easement for the New Office Building was accepted and approved pending engineering and legal approval. Motion carried

Upon motion by Mr. Libersat and seconded by Mr. Segura, the Board approved to move forward with Inlet Channel Dredging permit application. Motion carried.

Upon motion by Mr. Thibodeaux and seconded by Mr. Libersat, the Board approved to move forward with the Repairs for Ruth Canal Structure. Motion carried.

Upon motion by Mr. Thibodeaux and seconded by Mr. Segura, the Financial Statements for the period ending January 31, 2020 were accepted and approved. Motion carried.

Upon motion by Mr. Segura and seconded by Mr. Thibodeaux, the Board approved a Hartford litigation committee consisting of two members Edward Sonnier and Ralph Libersat with alternates Donald Segura and Tommy Thibodeaux.
