CALL TO ORDER

The meeting was called to order by Dr. Grady Coburn at 9:31 a.m.

AMEND THE AGENDA

Mr. Harry Schexnayder addressed the commission and requested that the commission amend the agenda to include a presentation from Brian Gueltig with the LSU AgCenter to give an update on the LSU AgCenter Pesticide Safety Education Program efforts to put in place a Private Applicator Training Certification Program.

Motion: Mr. Scotty Meador moved to approve amending the agenda to include a presentation by Mr. Gueltig under New Business under the LDAF Report. The motion was seconded by Mr. Billy Guthrie and passed unanimously.

NEW BUSINESS

LDAF Report:

Mr. Schexnayder gave the following updates:Mr. Schexnayder notified the commission that the department has not received any formal complaints regarding drift related to Over the Top Dicamba/2,4-D, though inspectors have noticed possible symptomology on different sensitive crops.

Mr. Schexnayder announced that the Certification and Training Plan submitted to the EPA has been unofficially approved by the Regional Administrator in Region 6. The plan moving forward will require changes to our rules and regulations. Mr. Schexnayder thanked Joe Ingrao for working hard to get the plan in, responding to comments, and making corrections to the EPA. Mr. Schexnayder discussed the rules that will be affected: 1) Certification categories will need to be revised and categories will need to be added related to fumigation and mosquito control. 2) Recertification standards and rules and regulations regarding recertification meetings and what topics are required to be covered will need to be revised. 3) Un-certified applicators that are making applications of restricted use pesticides must be trained annually by the certified applicator supervising the un-certified application of restricted use pesticides and the certified applicator will have to maintain a record of the annual training.

Mr. Schexnayder discussed the reappointment of commission members and stated that he would contact members individually to discuss their intentions of being reappointed.

Mr. Schexnayder introduced Mr. Brian Gueltig, LSU AgCenter. Mr. Gueltig provided a presentation on the computer-based Private Applicator Training Certification Program. Private Applicators will be allowed to go through the computer-based training or pass the Private Applicator Exam to receive their Private Applicator Certification.

Consideration of Ag Consultant Exam Applications: Mr. Joe Ingrao presented to the commission the recommendation of the Ad Hoc Committee of the Advisory Commission on Pesticides to approve Logan Vallee testing in category (3a) Agricultural Weed Control.

Motion: Ms. Jenny Buller moved to accept the recommendation of the Ad Hoc Committee of Advisory Commission on Pesticides to approve the applicant for agricultural consultant certification testing. The motion was seconded by Mr. George Bragg and passed unanimously.

FUTURE MEETING

Mr. Schexnayder addressed the commission regarding the future meeting date. After some discussion Mr. Schexnayder stated that he would email the commission members regarding an available future meeting date.

Dr. Grady Coburn announced that he would not be seeking reappointment to the commission.

PUBLIC COMMENTS

Dr. Ansel Rankins thanked Dr. Coburn for his service on the commission. Dr. Coburn received a round of applause from the commission and staff.

ADJOURNMENT

Motion: Mr. Scotty Meador moved to adjourn the meeting. The motion was seconded by Mr. Johnny Landry and passed unanimously. The meeting adjourned at 10:53 a.m.
