# VI. CONSIDERATION OF LICENSE APPLICATION FOR APPROVAL: (New)

### A. GRAIN DEALER

### 1. Erwin Keith, Inc.

A motion was made by Mr. Donald Berken and seconded by Mr. Tom Russell to go into Executive Session discuss the financial information of the applicant. The motion carried unanimously.

A motion was made by Mr. Ronald Petree and seconded by Mr. Tom Russell to come out of Executive Session. The motion carried unanimously.

A motion was made by Mr. Kevin Webb and seconded by Mr. Tom Russell to approve the following grain dealer license application, Erwin Keith, Inc. The motion carried unanimously.

#### VII. NEW BUSINESS

### 1. Renewal Licensing

Mrs. Kyra Fitzgerald stated that the renewal packets were mailed out on March 6, 2017.

### 2. Legislation

Mr. Dane Morgan, Assistant Commissioner, Office of Management and Finance, informed the board that during the 2017 First Extraordinary Session, House Concurrent Resolution No. 1 was Enrolled and therefore became a concern for the Louisiana Agricultural Commodities Commission in that it proposed "developing a procedure necessary to implement a process to allocate money deposited into the state treasury from constitutional and statutory dedications that flow through the Bond Security and Redemption Fund for the purpose of paying debt service on obligations secured by the full faith and credit of the state beginning in Fiscal Year 2017-2018." Mr. Morgan explained the issue and suggested that the board talk to legislators and others in the industry regarding HCR1 and its effect on the Grain and Cotton Indemnity Fund, the Self-Insurance Fund and the Agricultural Commodity Dealer and Warehouse fund. Mr. Morgan explained that the legislature intends to access a percentage of the budgeted money allowed in these funds for the purpose of paying state bond debt. Therefore, the board proposed that a formal letter, signed by the chairman of the board, state its opposition to House Concurrent Resolution No. 1 and the access to these funds, and agrees with Commissioner Mike Strains' position that the constitution and laws which established the Louisiana Department of Agriculture and Forestry's statutorily dedicated funds do not allow for the use towards general bond debt payment as suggested in HCR1 and therefore should be exempt from use thereof.

A motion was made by Mr. Donald Berken and seconded by Mr. Tom Russell authorizing the staff to formulate a letter, signed by the chairman of the board, notifying legislators of LACC's opposition to HCR1 and agreeing with Commissioner Strains' position against accessing funds that are statutorily dedicated funds paid via assessments and some of which are considered "insurance" paid by and for the protection of Louisiana producers.

A motion was made by Mr. Donald Berken and seconded by Mr. Ronald Petree to go into Executive Session to discuss an issue regarding the financial information and possible licensure of a seed dealer. The motion carried unanimously.

A motion was made by Mr. Tom Russell and seconded by Mr. Kevin Webb to come out of Executive Session. The motion carried unanimously.
