VI. Old Business

1. Grain and Cotton Indemnity Fund Balance

Mrs. Dupree reported that there is approximately a balance of \$474,000 in the Grain and Cotton Indemnity Fund. She stated that \$50,000 was withheld until further direction from the bankruptcy judge.

Mrs. Dupree stated that there is a facility that is currently licensed as a Grain Dealer and is applying for a renewal license. She stated there was a discrepancy in a regular monthly assessment and the facility was notified.

Mrs. Dupree stated that LDAF auditors, Mr. John Smith and Jeff Fabre, visited the facility to photocopy the documentation and was allowed to view the documentation but was not allowed to photocopy the documentation. She stated that a letter was sent to the facility May 19, 2011, informing the facility that if there was no response by May 31, 2011, this matter would be presented before the Commission at the next meeting. Mrs. Dupree stated a letter stating the Attorney General's opinion that the auditors should be allowed to photocopy the documentation, was enclosed with her letter.

Mrs. Dupree stated a check was received in the mail from the facility, Friday, May 27, 2011, with a letter enclosed still disputing the auditor's results.

A motion was made by Mr. Kenny Self to go into Executive and seconded by Mr. Donald Berken. The motion carried unanimously.

A motion was made by Mr. Filmore Bordelon and seconded by Mr. Donald Zaunbrecher to come out of Executive Session. The motion carried unanimously.

Mr. Smith received a directive from the Commission to visit the facility to assure that the facility is up to date on the assessments before the next meeting on June 20, 2011.

2. Moisture Meter Update

Mrs. Dupree stated that the Moisture Meter registration period has ended. She reported that in the South Louisiana area there were 87 registered moisture meters and in the North Louisiana area there were 62 registered moisture meters. Mrs. Dupree stated that there were only a few meters that did not pass the inspection.

3. Legislative Update

Mrs. Dupree stated that Senate Bill 89 is currently on the House Calendar for final passage. She stated that the bill is to allow the LDAF auditors, Mr. Smith and Mr. Fabre, authority to copy documentation from companies relative to the financial audits. Mrs. Dupree stated that the second part of the bill is relative to the question of the Commission's authority for budget and spending. She stated that after the previous meeting it needed to be clarified that the Commission is actually not in charge of spending for this part of the department. She is correcting the language in the law to give the Commissioner the authority to maneuver funds when necessary.

4. Budget Update

Mr. Benjy Rayburn gave a financial report on the budget for the current fiscal year. He stated that the report includes the year to date actual revenues and expenditures as well as the budgeted revenue and expenditure authority. He stated actual revenues were broken

down into the different categories collected from July 1, 2010 through April 30, 2011 and actual expenditures were categorized through May 26, 2011.

VII. New Business

1. Late Applications

Mrs. Dupree stated that she and Mr. Rayburn discussed how to enforce the penalty for late applications and how much to impose on the licensees. She stated that there were six applicants that were officially late this year.

The Commission directed Mrs. Dupree to send a certified letter to the six late applicants stating that due to this being the first year of imposing penalties; the Commission is waiving the fees. Mrs. Dupree stated that she would send a certified letter and also that she would correct the penalty statutes, with the Commission's permission, to make it as clear as possible within the confines of the law.

VIII. Public Comment

Mr. Robert Hanks asked if there was any public comment. There was none.

IX. Date for the Next Meeting

The date of the next meeting is scheduled for June 20, 2011, 9:30 a.m.

X. Adjournment
