

**Minutes of the Meeting of the
Louisiana State Board of Social Work Examiners
April 29, 2011**

John McBride, LCSW, Chairman, called the meeting to order at 9:00 a.m., Friday, April 29, 2011, in the Conference Room at the Board office located at 18550 Highland Road, Suite B, Baton Rouge, Louisiana. Emily Efferson, Administrator, and Regina Breaux, Administrative Assistant, were present for the entire meeting. Other individuals present for a portion of the meeting were Stephanie Nassrah, Kristin Wiedemann, Rebecca McDaniel, Taylor Thompson, Alison Miller, Meagan Curtis, Kristin Marrs, Kristin MacRae, Joe Montaldi, Lucy Cordts, and Melissa Smithee.

Hope Himel-Benson, LCSW, conducted roll call. Board members present included Evelyn Jenkins, LCSW, John McBride, LCSW, Hope Himel-Benson, LCSW, Michael Hickerson, RSW, Lisa Lipsey, LCSW, and Naaman Stewart, LMSW.

PUBLIC COMMENTS

Rebecca McDaniel, NASW Intern, informed the board that Senator Mount has introduced a bill to combine the LPC board and Psychology board. The Louisiana State Board of Social Work Examiners has not been included in the bill. However, NASW will continue to monitor the bill.

AGENDA

Motion was made by Michael Hickerson, seconded by Naaman Stewart and unanimously carried, to table item 8e, Public Education, until the June 10, 2011 meeting and to accept the agenda as amended.

PRESENTATION OF CONSENT AGREEMENT AND ORDERS

Emalie Boyce, Assistant Attorney General, presented the board with a Consent Agreement and Order for **Ashley Kinman**, RSW, which had been previously negotiated and agreed to by Ms. Kinman in resolution of Complaint #2011-10. Motion was made by Hope Himel-Benson, seconded by Michael Hickerson and unanimously carried, to accept the Consent Agreement and Order as presented.

Jessica Donaho, LMSW, was unable to attend the meeting. The presentation of her Consent Agreement and Order has been rescheduled for June 10, 2011.

Emalie Boyce, Assistant Attorney General, presented the board with a Consent Agreement and Order for **Charisse Spland-Gray**, CSW, which had been previously negotiated and agreed to by Ms. Spland-Gray in resolution of Complaint #2011-49. Motion was made by Naaman Stewart, seconded by Evelyn Jenkins and unanimously carried, to accept the Consent Agreement and Order as presented.

Emalie Boyce, Assistant Attorney General, presented the board with a Consent Agreement and Order for **Judy Soileau**, LMSW, which had been previously

negotiated and agreed to by Ms. Soileau in resolution of Complaint #2010-149. Motion was made by Evelyn Jenkins, seconded by Naaman Stewart and unanimously carried, to accept the Consent Agreement and Order as presented.

A hearing in the matter of Administrative Complaint #2009-60 against Juanita Anderson-Hilton was conducted. George Papale was present as legal counsel for the Board. Emalie Boyce, Assistant Attorney General, was present as prosecution on behalf of the State of Louisiana. A court reporter from Baton Rouge Court Reporters was present to record the proceedings. The hearing panel consisted of board members, Michael Hickerson, RSW, Naaman Stewart, LMSW, and John McBride, LCSW. John McBride served as the Presiding Officer.

The hearing panel consisted of board members, Michael Hickerson, RSW, Naaman Stewart, LMSW, Hope Himel-Benson, LCSW, Evelyn Jenkins, LCSW, and John McBride, LCSW. John McBride served as the Presiding Officer.

Motion was made by Michael Hickerson, seconded by Evelyn Jenkins and unanimously carried, to come out of Executive Session at 1:30 p.m. to make the following motions:

MONITORING REPORTS-IMPAIRED PROFESSIONAL PROGRAM (IPP)

Motion was made by Michael Hickerson, seconded by Hope Himel-Benson and unanimously carried, to accept the report submitted by Sherril Rudd, LCSW, IPP Manager.

Motion was made by Evelyn Jenkins, seconded by Michael Hickerson and unanimously carried, to summarily suspend LMSW#8248 held by Gary Cantrell and to send notice to the Attorney General's office of the summary suspension and request that an Administrative Complaint be sent to Mr. Cantrell. The administrative hearing is scheduled for Friday, June 10, 2011.

Members of the board requested the IPP manager submit a letter to **JD-10** requesting documentation from his physician updating her on his medical condition and to inquire if he is planning on returning to the field of social work.

Members of the board requested the IPP manager to find out if **JG-09** is working. Her Consent Agreement and Order requires her to be supervised while practicing social work.

Motion was made by Michael Hickerson, seconded by Hope Himel-Benson and unanimously carried, to summarily suspend LMSW#7119 held by Charles Netterville, Jr. "Billy" and to send notice to the Attorney General's office of the summary suspension and request that an Administrative Complaint be sent to Mr. Netterville. The administrative hearing is scheduled for Friday, June 10, 2011.

Motion was made by Michael Hickerson, seconded by Evelyn Jenkins and unanimously carried, to allow the Assistant Attorney General to renegotiate a Consent Agreement and Order for **JM-10** to include suspending his license for six consecutive months and to limit his social work practice to an agency setting. Additionally, participant is to be advised that 100% compliance is required or time required for participating in the IPP starts over.

Motion was made by Evelyn Jenkins, seconded by Hope Himel-Benson and unanimously carried, to deny the request made by **MS-08** and to uphold their previous decision that MS-08 is required to participate in the IPP an additional three months due to missed call-ins.

Motion was made by Hope Himel-Benson, seconded by Evelyn Jenkins and unanimously carried, to begin counting the twelve months for **JT-09**, from the date that he has resumed compliance. The twelve months will begin as of April 29, 2011.

Motion was made by Michael Hickerson, seconded by Evelyn Jenkins and unanimously carried, to send notice to **DW-09** that his license will be summarily suspended should he not become compliant with the program within 30 days.

MINUTES

Motion was made by Michael Hickerson, seconded by Evelyn Jenkins and unanimously carried, to accept the minutes as presented for the March 18, 2011 board meeting.

CORRESPONDENCE

Members of the board reviewed correspondence submitted by **Danny Johnson**. Mr. Johnson asked the board what is the generally accepted and/or legal terminology used for the process by which social worker's establish a mental diagnosis. Mr. Johnson was referred to Rule 109A(1), 109C and Rule 111, of the Rules, Standards and Procedures.

Members of the board reviewed correspondence submitted by **Brandie Bruno, LMSW**. Ms. Bruno asked the board if she should allow someone to observe her group and family sessions if she is provided with a court order. Members of the board advised Ms. Bruno that she should comply with the court order. Members of the board advised Ms. Bruno, that as the situation has been presented, it does not appear that she would be in violation of the Rules, Standards and Procedures or the Practice Act

Members of the board reviewed correspondence submitted by **Ronald Schneider, LCSW**. Mr. Schneider requested the board to consider allowing him to obtain continuing education hours by way of independent study. Mr. Schneider's request was denied and he was referred to Rule 317(M)(11), of the Rules, Standards and Procedures.

Members of the board reviewed correspondence submitted by **Mary Livingston, LCSW**. Ms. Livingston requested the board to waive her continuing education requirements due to her current medical condition. Ms. Livingston was advised that the board is unable to waive her continuing education requirements. However, the board members agreed to allow Ms. Livingston to complete all 20 of her hours via distance learning and granted her a 6 month extension to complete her hours. Ms. Livingston was advised that she must complete 20 continuing education hours on or before December 31, 2011.

Member of the board reviewed correspondence submitted by **Kimberly Pintado, LMSW**, and **Kristin Richards, LMSW**. Ms. Pintado and Ms. Richards requested the board to consider allowing the work that they have completed in their Ph.D program to count toward their annual continuing education requirement. Members of the board denied the request. The Rules, Standards and Procedures do not allow such coursework to be counted toward the continuing education requirement. However, Rule 317(M)(10), does allow up to five hours of continuing education for preparation of substantial written material with content applicable to social work practice which requires literature search, research, and explication of social work content.

Members of the board reviewed correspondence submitted by **Stacey Griffin, LCSW**. Ms. Griffin requested the board to consider a situation where a minor client disclosed to her social worker that she has been smoking marijuana and the minor child's right to confidentiality. Members of the board agreed to provide Ms. Griffin with a copy of an opinion on "Children and Adolescent's Right to Confidentiality" recently submitted by George Papale.

BOARD/STAFF ISSUES

Participation Agreement for Impaired Professional Program

Members of the board reviewed a draft of the revised Participation Agreement submitted by George Papale, Attorney at Law. The board requested that the draft be provided to the IPP Committee for their review and consideration.

Compliance Hearing for Freddie Williams, MSW

Mr. Williams requested a Compliance Hearing to appeal the board's decision to deny his LMSW application on March 18, 2011. His application was denied because he did not indicate on his application that he had any state or federal charges. However, his criminal background check documented a charge on May 23, 1967. Mr. Williams testified that he received a speeding ticket and paid the fine late. He was unaware that there had been any charges against him.

Compliance Hearing for Joycelyn Haynes

Ms. Haynes requested a Compliance Hearing with the board because they denied her RSW application on March 18, 2011. Her application was denied because she did not indicate on her application that she had any state or federal charges. However, her criminal background check documented a charge on January 12, 1976. Ms. Haynes testified that she did not recall the incident at the time that she applied for the RSW. She stated that she was grocery shopping and one of items in her basket was accidentally not paid for when she left the store. She testified that she offered to pay for the item, but was refused.

Compliance Hearing for LaRhonda Duncan, MSW

Ms. Duncan requested a Compliance Hearing with the board because they denied her LMSW application on March 18, 2011. Her application was denied because she did not indicate on her application that she had any state or federal charges. However, her criminal background check documented a charge on October 25, 2006. Ms. Duncan testified that she received a traffic ticket for no insurance. She knew someone at the police department and was told that the ticket would get "fixed." She was later pulled over for a traffic violation and found out that the ticket had not been "fixed" and that her license had been suspended. She missed her court date for the traffic violation. Ms. Duncan testified that she believes that she only had to pay a \$75.00 fine.

2010 ASWB Examination Pass Rates

Members of the board reviewed the 2010 Pass/Fail data submitted by ASWB.

Members of the board reviewed correspondence from Ms. Weisner. The NASW-LA Chapter has recommended that Carol Miles, LCSW, serve on the IPP Committee.

Compliance Hearing for Geoi Hodges, MSW

Ms. Hodges requested a Compliance Hearing with the board because they denied her LMSW application on March 18, 2011. Her application was denied because she did not indicate on her application that she had any state or federal charges. However, her criminal background check documented a charge on November 5, 1999. Ms. Hodges testified that she was arrested but never charged. She also stated that she is currently working on getting her juvenile record sealed. She also testified that her employer told her that she can work as long as she applies for the license within 120 days.


