# Commission Meeting **MINUTES**

#### I. CALL TO ORDER

A quarterly meeting of the Louisiana Commission on Law Enforcement and Administration of Criminal Justice was held on Thursday, September 29, 2022, at the Cook Conference Center at LSU. In the absence of Sheriff Sid J. Gautreaux, III, Commission Chairman, and the Honorable James "Jay" Lemoine, Commission Vice-Chairman, the meeting was called to order at 10:00 a.m. by Chief Jim Craft, Executive Director of the Commission on Law Enforcement.

#### III. ADOPTION OF AGENDA

Chief Craft called for a motion to adopt the agenda. A motion was made by Chief Landry, seconded by Sheriff Tubbs, and the motion passed without opposition.

#### IV. OLD BUSINESS

#### A. Consideration of Minutes

Chief Craft called for a motion to approve the minutes from the meeting held on June 23, 2022. A motion was made by Chief Landry, seconded by Sheriff Tubbs, and the motion passed without opposition.

#### B. Report of the Priorities Committee

Chief Craft reported that, in accordance with Title 22, Chapter 41, Section 4105 (H), on September 1, 2022, an emergency meeting of the Priorities Committee was called to consider a

federal funding increase from the June 23, 2022 Commission meeting for the Juvenile Justice and Delinquency Prevention Program (LCLE Subgrant #4828, DMC/RED Coordinator). The Priorities Committee approved this funding increase on September 6, 2022.

On September 14, 2022, the Priorities Committee received all allocations, applications, proposed increases, and sole source requests for the September Commission meeting via electronic mail-out. The Priorities Committee reviewed these items and recommended approval on September 16, 2022. All items were recommended for consideration at the September 29, 2022 Commission meeting.

This concludes the report of the Priorities Committee.

Chief Craft called for a motion to accept the report. A motion was made by Chief Landry, seconded by Sheriff Ard, and the motion unanimously passed.

#### C. Report of the Victim Services Advisory Board

Chief Deputy Gary "Stitch" Guillory, Board Chairman, reported that the Victim Services Advisory Committee met at 10:30 a.m. on Wednesday, September 28, 2022, at the Cook Conference Center in Baton Rouge, LA. A membership quorum was present.

The Board recommended approval of the following:

- 2 FY 2021 SASP increases totaling \$31,889
- 1 FY 2021 VAWA allocation totaling \$9,807
- 1 FY 2021 VAWA application totaling \$9,807
- 1 FY 2021 VAWA increase totaling \$3,249
- 1 FY 2021 VAWA waiver totaling \$18,409
- 96 FY 2021 VOCA allocations totaling \$5,887,736
- 41 FY 2021 VOCA applications totaling \$3,003,140
- 4 FY 2020 VOCA applications totaling \$659,022
- 18 FY 2020 VOCA increases totaling \$190,000

### D. Report of the Juvenile Justice and Delinquency Prevention (JJDP) Advisory Board

Ms. ViEve Martin-Kohrs, JJDP Advisory Board Member, reported that the Juvenile Justice and Delinquency Prevention Advisory Board met at 9:00 a.m. on Wednesday, September 28, 2022, at the Cook Conference Center in Baton Rouge, LA. A membership quorum was present.

There were no applications for consideration at this meeting. Updated advisory board policies and bylaws were approved on this date. A discussion concerning data collection for racial and ethnic disparities was also conducted.

This concludes the report of the Juvenile Justice and Delinquency Prevention Advisory Board.

Chief Craft called for a motion to accept the report. A motion was made by Sheriff Stassi, seconded by Chief Deputy Guillory, and the motion unanimously passed.

#### E. Report of the Drug Control and Violent Crime Policy Board

Col. Carlos Stout, Board Chairman, reported that the Drug Control and Violent Crime Policy Board met at 2:00 p.m. on Wednesday, September 28, 2022, at the Cook Conference Center. A membership quorum was present.

The Board recommended approval of the following:

- 32 FY 2021 allocations totaling \$1,787,129
- 28 FY 2021 applications totaling \$1,336,429
- 3 FY 2021 confidential applications totaling \$50,700
- 1 FY 2019 increase totaling \$66,505 and any future FY 2019 residual funds for Grant #6047
- 1 sole source purchase for City of New Orleans, New Orleans Police Department, Homicide Equipment totaling \$39,146
- Approval of all requested, received, and reviewed waiver requests and sole source requests

All of this activity is listed in the eGrants system

This concludes the Drug Control and Violent Crime Policy Board Report.

Chief Craft called for a motion to accept the report. A motion was made by Mr. Bergeron, seconded by Sheriff Stassi, and the motion carried without opposition.

#### F. Report of the Drug Abuse Resistance Education (DARE) Advisory Board

In the absence of Sheriff Julian Whittington, Board Chairman, Sheriff Mike Tubbs, Board Member, reported that the Drug Abuse Resistance Education (DARE) Advisory Board met at 3:00 p.m. on Wednesday, September 28, 2022, at the Cook Conference Center. A membership quorum was present.

The Board recommended approval of the following:

• 61 DARE state-funded grant applications to 15 police departments, 42 parish sheriff's offices, 1 city constable's office, 1 DARE training center, and 2 city marshal's office.

The DARE Advisory Board recommends approval to the Commission for 61 applications with the understanding that cuts will be made to the grants based on the available DARE budget.

This concludes the report of the Drug Abuse Resistance Education (DARE) Advisory Board.

Chief Craft called for a motion to accept the report. A motion was made by Chief Deputy Guillory, seconded by Sheriff Stassi, and the motion passed without opposition.

Chief Craft called for Other Old Business, and there was none to discuss.

#### VI. <u>NEW BUSINESS</u>

#### A. Revised Commission Policies

Commission members were previously provided a copy of the revised Commission Policies. After a brief report by Chief Craft, he called for a motion to accept the draft. Any additional changes made to the policies will be forwarded to the Commission members for their review. A motion was made by Col. Stout, seconded by Sheriff Ard, and the motion passed without opposition.

#### B. Presentation of Grant District Applications

Chief Craft called for a presentation of the District grant applications. A motion was made by Sheriff Tubbs to approve all of the District grant applications *in globo*. The motion was seconded by Col. Stout, and the motion carried without opposition.

#### VII. OTHER BUSINESS

#### A. Next Commission Meeting Date

Chief Craft announced that the next quarterly Commission meeting will be held on Thursday, December 8, 2022, at the Cook Hotel and Conference Center at LSU. The advisory boards will meet on Wednesday, December 7, 2022, at the same location.

#### B. 2022 Louisiana Law Enforcement Medal of Honor Ceremony

Chief Craft announced that the Louisiana Commission on Law Enforcement will host the 2022 Louisiana Law Enforcement Medal of Honor Ceremony today at 2:00 p.m. at the Old State Capitol, 100 North Blvd., Baton Rouge, LA. He invited and encouraged all to attend. This year's ceremony will honor nine law enforcement officers and one canine who lost their lives in the line of duty during 2021.

#### VIII. ADJOURNMENT

Chief Craft reported that a total of \$12,566,696 was awarded to deserving agencies at today's meeting and called for a motion to adjourn.

A motion to adjourn was made by Sheriff Tubbs, seconded by Col. Stout, and the motion unanimously passed. The meeting adjourned at 10:20 a.m.
