Commission Meeting MINUTES

Hilton Capitol Center 201 Lafayette Street Baton Rouge, Louisiana 70801 September 19, 2019 11:30 a.m.

I. CALL TO ORDER

A quarterly meeting of the Louisiana Commission on Law Enforcement and Administration of Criminal Justice was held on Thursday, September 19, 2019, at the Hilton Capitol Center in Baton Rouge, Louisiana. In the absence of Sheriff Sid J. Gautreaux, III, Commission Chairman, and Honorable James "Jay" Lemoine, Commission Vice-Chairman, the meeting was conducted by Chief Jim Craft, Executive Director of the Louisiana Commission on Law Enforcement and Administration of Criminal Justice. Chief Craft called the meeting to order at 11:40 a.m.

Chief Craft thanked those who attended the 2019 Louisiana Law Enforcement Medal of Honor Ceremony which was held prior to the Commission meeting at the Louisiana Old State Capitol. He requested a moment of silence to remember the four law enforcement officers and one canine who were honored at the ceremony: Officer Christopher Michael Lawton, Zachary Police Department; Officer Jason Michael Seals, Slidell Police Department; Agent Cadet Immanuel James Washington, Louisiana Department of Wildlife and Fisheries; Officer Ayrian Michelle Williams, Monroe Police Department; and "Boco" (canine), Lincoln Parish Sheriff's Office.

III. ADOPTION OF AGENDA

Chief Craft called for a motion to adopt the agenda. A motion was made by Sheriff Cazes, seconded by Major Brown, and the motion carried.

IV. OLD BUSINESS

A. Consideration of Minutes

Chief Craft called for a motion to approve the minutes from the meeting held on

May 30, 2019. A motion was made by Sheriff Cazes, seconded by Chief Landry, and the motion carried.

B. Report of the Priorities Committee

Chief Craft reported that, on August 28, 2019, the Priorities Committee received all allocations, applications, proposed increases, waiver requests, and sole source requests via electronic mail-out. The Priorities Committee reviewed these items and recommended approval on September 3, 2019.

This concludes the report of the Priorities Committee.

Chief Craft called for a motion to accept the report. A motion was made by Colonel Stout, seconded by Chief Hutchinson, and the motion passed.

C. Report of the Victim Services Advisory Board

On behalf of Chief Deputy Gary "Stitch" Guillory, Board Chairman, Chief Craft reported that the Victim Services Advisory Committee met at 10:30 a.m. on Wednesday, September 18, 2019, at the Baton Rouge Marriott. A membership quorum was present.

The Board recommended the approval of the following:

- 2 FY 2016 Title II increases totaling \$5,743

Chief Craft called for a motion to accept the report. A motion was made by Sheriff Cazes, seconded by Chief Layrisson, and the motion passed.

E. Report of the Drug Control and Violent Crime Policy Board

Colonel Carlos Stout, Board Chairman, reported that the Drug Control and Violent Crime Policy Board met at 2:00 p.m. on Wednesday, September 18, 2019, at the Baton Rouge Marriott. A membership quorum was present.

The Board recommended approval of the following:

- 48 FY 2018 allocations totaling \$1,811,650
- 5 FY 2017 applications totaling \$348,946
- 35 FY 2018 applications totaling \$1,496,727
- Request all future FY 2016 JAG residual funds that become available be given to District 8 (Grant #3907)
- 4 waiver requests (48-month rule)
- Request approval of all other waiver requests submitted with application
- All of this activity is listed in the eGrants system

This concludes the Drug Control and Violent Crime Policy Board Report.

Chief Craft called for a motion to accept the report. A motion was made by Chief Bonner and seconded by Sheriff Cazes. The motion passed.

F. Report of the Drug Abuse Resistance Education (DARE) Advisory Board

On behalf of Sheriff Mike Stone, Board Chairman, Chief Craft reported that the Drug Abuse Resistance Education (D.A.R.E.) Advisory Board met at 3:00 p.m. on Wednesday, September 18, 2019, at the Baton Rouge Marriott. A membership quorum was present.

The Board recommended approval of the following:

- 66 D.A.R.E. state-funded grant applications to 14 police departments, 49 sheriffs' offices, one city constable's office, one D.A.R.E. training center, and one city marshal's office.
- Probation for one grant application for the City of Baker, due to not completing the program for the prior two grant periods.

• Approval is recommended to the Commission for 66 applications and one probationary application reviewed with the understanding that cuts will be made to the grants based on the available D.A.R.E. budget.

Chief Craft called for a motion to approve. A motion was made by Major Brown, seconded by Mr. Belton, and the motion passed.

V. CALL FOR OTHER OLD BUSINESS

Chief Craft called for Other Old Business, and there was none to discuss.

VI. NEW BUSINESS

A. Consideration of Waiver Request for Capital Area Family Justice Center

Ms. Nakia Harris, LCLE STOP/SASP Program Manager, requested the Commission's consideration of one waiver request for the Capital Area Family Justice Center which would allow the expenditure of more than the maximum \$25,000 on renovations.

Chief Craft called for a motion to approve. A motion was made by Sheriff Cazes, seconded by Sheriff Tubbs, and the motion passed.

B. Presentation of Districts' Grant Applications

Chief Craft called for a presentation of the District grant applications. A motion was made by Sheriff Tubbs to approve all of the District grant applications *in globo*. The motion was seconded by Colonel Stout, and the motion passed.

VII. OTHER BUSINESS

A. Agency Rule Review

In accordance with R.S. 49:953 (C) (2)(a) (Act 454 of the Regular Legislative Session), Mr. Bob Wertz explained that a Public Hearing must be conducted at the September Commission Meeting to afford all interested persons an opportunity to submit data, views, or arguments, either orally or in writing regarding the proposed LCLE Administrative Rule changes, as published in *Potpourri*, Louisiana Register Vol. 45, No. 08, dated August 20, 2019. Mr. Wertz opened the Public Hearing to receive public comment, and none were received. Mr. Wertz announced the closure of the Public Hearing. Chief Craft called for a motion to adopt the changes. A motion was made by Chief Bonner, seconded by Captain Richards, and motion was approved.

B. Innocence Compensation Fund - Attorney General's Opinion

Chief Craft requested the Commission's approval to seek an opinion from the Attorney General's Office as to whether or not the loss of life opportunities is inheritable regarding compensation paid from the Innocence Compensation Fund. A motion was made by Judge White, seconded by Chief Hutchinson, and the motion carried.

C. Next Commission Meeting

Chief Craft announced that the next Commission Meeting will be held on Thursday, December 5, 2019 at the Baton Rouge Marriott. The Advisory Board meetings will be held on Wednesday, December 4, 2019, at the same location.

VIII. ADJOURNMENT

A motion to adjourn was made by Major Brown, seconded by Captain Richards, and the motion passed. The meeting adjourned at 12:05 p.m.
