Ms. Shorty made a motion to award \$1,465.98 for MEDICAL. Ms. White seconded the motion and the motion passed unanimously.

VII. OTHER BUSINESS

The Board discussed defining guidelines (based on CDC guidelines) for the amounts we will pay for each medication and testing.

The Board discussed not using a victim's criminal history as a reason to deny victims of domestic violence who need an emergency award for relocation because there is a threat of imminent danger as long as there is documentation of this from the district attorney's office or the law enforcement agency. Ms. Shorty made a motion to pass this and have it go into effect with crimes that happen as of October 16, 2018. Mr. Guillory seconded the motion and the motion passed unanimously.

The next sexual assault meeting is scheduled for January 17, 2019.

The next CVR Board meeting is scheduled for November 13, 2018.

Dr. Duchmann agreed to only send him mental health cases/claims and to send those immediately upon receiving them.

Ms. Shorty made a motion to to adjourn the meeting. Mr. Guillory seconded the motion. Ms. Tonkovich adjourned the meeting at 11:30 p.m.
