Linda Gautier presented one (1) Confidential Application for consideration.

1. B12-4-003, Acadia Parish Sheriff's Office, *Multi-Jurisdictional Task Force*, \$15,364 (Continuation); Representative: Cathy Savant

With no questions or comments, Honorable Michael Cassidy made a motion to recommend approval of the **Confidential Application**. Sheriff Mike Tubbs seconded the motion. The motion carried without opposition. Cathy Savant abstained.

H. Other New Business, Bob Miller

1. 2013 Wrongful Conviction Demonstration Project for Louisiana,

Bob Miller reported to the Board that BJA (Bureau of Justice Assistant) is considering a 2013 Wrongful Conviction Demonstration Project for Louisiana. He mentioned that we were notified that funds (\$67,744) were available for Louisiana. He said that he would provide an update, at the November meeting, once BJA has made their decision.

I. Added: Increasing the Byrne 2013 Justice Assistance Grant Allocation to \$3,700,242

Bob Miller apprised the Board that Byrne JAG Program had received the 2013 Award and presented the highlights.

- Increased amount above initial Federal allocation to \$164,417.
- Funds were allocated to the Districts, following the same 2012 Federal funds formula.
- 2013 Award reflects a slight increase (2.6%) above the 2012 Byrne JAG Award (see attachment 2 - from the Federal Application)
- 10% of 2013 Award has been placed in the Administrative Funds account.
- Pass-through will continue to be more than the federally required amount of 57.9% for local projects.
- Program funds were divided into 30% for State Level Projects, and 70% for the Districts.
