## Executive Director Report Operations Update

Paige Hargrove, LERN Executive Director, advised the Board that the annual report has been completed and is posted on the LERN website.

Executive Director Hargrove advised that new board member Joseph Kanter, MD, will serve as LDH representative on the LERN Executive Committee.

Executive Director Hargrove reminded the Board that financial disclosures are due May 15, 2021.

Executive Director Hargrove was advised the Board that 112 paramedics have completed the Burn Basics Course to date.

Executive Director Hargrove advised that Stroke/STEMI attestations were distributed to CEO's on April 5, 2021; and that 45 of the 111 attestations have been returned to date.

The LERN Call Center is doing well and volume is up in 2021. Executive Director Hargrove shared a power point on LERN Call Center Volume for the first quarter of 2021, showing a significant increase over the first quarter in previous years. See Exhibit B, page 6.

## Trauma System Update

Dr. Sutherland, LERN Trauma Medical Director, advised the board of his substantial efforts and the results thereof, in working toward development of a more complete trauma system in the state of Louisiana. See pp. 7-8 of <u>Attachment B</u>.

## Stroke System Update

Dr. Martin-Schild, LERN Stroke Medical Director, reported recent success in obtaining data from all stroke hospitals (ASRH, PSC, PSC-E, TSC, and CSC) and advised the Board of the continuing efforts of herself, the State Stroke Workgroup committee, LERN and the Stroke Education Workgroup. ## STEMI Update

Dr. Christopher White, LERN STEMI Medical Director, updated the board on STEMI system in Louisiana. Dr. White advised that the LERN Regional Coordinators are meeting with every STEMI Referral Center in the state to provide materials and review the system. See pp. 10-
