IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that FIVE THOUSAND (\$5,000.00) DOLLARS of the fine be suspended conditioned upon N. O. Wholesale, LLC, 301 David Drive, Metairie, Louisiana 70003, being placed on ONE (1) YEAR probation beginning the date this Consent Judgment is rendered and signed and adhering to all Rules and Regulations of this Commission and Louisiana laws applicable to this Commission during the probationary period. In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that N. O. Wholesale, LLC, 301 David Drive, Metairie, Louisiana 70003, pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of THREE HUNDRED (\$300.00) DOLLARS.

In the event of a violation during the probationary period, the suspended portion of the fine shall become due and payable in full.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that Moore and Moore Visions LLC DBA Moore Motors, 13503 Florida Boulevard, Baton Rouge, Louisiana 70815, pay the cost of the pre-hearing conference to the Louisiana Motor Vehicle Commission in the amount of THREE HUNDRED (\$300.00) DOLLARS.


