Old Business

- Minutes of October 2023 meeting. Minutes were reviewed. On the motion of Brenda Martin, duly seconded by Kim Solari, all present voted unanimously to approve and accept the minutes of the October 13, 2023 OTAC meeting with no changes.
 - No public comment.

New Business

- 2. Questions from Louisiana licensed occupational therapist Julia Cahill regarding pain coaching business.
 - Occupational therapist Julia Cahill was present to provide OTAC with further information regarding the question that she had previously sent to the Board:

I am in the process of starting a pain coaching business with the intent to serve clients from all over and I want to make sure that the education I am proving is able to fall under the umbrella of coaching and not OT so that services can be provided over state lines. Many of the other therapists I have discussed with...were able to distinguish themselves by NOT providing intake evals, specific treatment plans, goal setting, progress notes, or discharge notes to further clarify that the services provided are coaching and not therapy. If allowed I would like to mention my past history as an OT to my clients and encourage them to seek OT treatment if specific information or treatment is desired. Of the information I intend to provide, much of it relies on client self reflection, self goal setting, and self assessment with some strategy training provided as examples.

Would this allow me to act as a coach, or are there other steps I need to take to ensure that I am acting as a coach and not a therapist as I pursue my new role? Thank you for all your time and clarification!

- Ms. Cahill discussed her intended client activities. OTAC members discussed the
 difference between tailoring and adapting interventions versus providing general
 educational information. Questions were raised regarding whether her activities could
 expose her to liability. Ms. Cahill stated she is still looking into that. Concerns were
 expressed. OTAC will request further information to go any further.

3. Executive Session for licensure recommendation for Contact #296217

- Motion to move into Executive session by Darbi Philibert, duly seconded by Ingrid Franc at 11:21 AM. All present voted unanimously to move into Executive session.
- Motion to return to Public session by Ingrid Franc, duly seconded by Brenda Martin at 11:40 AM. All present voted unanimously to return to Public session.
- The Chair held a vote on the licensure recommendation. Darbi Philibert motioned to recommend that Contact #296217 be requested to provide a letter of recommendation from her supervising OT. Kim Solari seconded the motion. All members present voted unanimously in favor.

Old Business

4. Use of the title of Doctor

- The OTAC reviewed the language written by Patricia Wilton regarding the use of the title
 of Doctor by occupational therapists in Louisiana. The recommended language makes it
 clear that an occupational therapist must identify themselves as an occupational
 therapist when using the title of "Doctor" preceding their name.
- Darbi Philibert motions to approve this addition to the Rules. Ingrid Franc seconded it.
 All members present voted unanimously in favor.
 - No public comment.

5. Definitions for the Rules

- Darbi reviewed the current format for Definitions in the OT Rules in which they are divided by subject matter. Patricia Wilton clarified that we do not need to retain that format and all definitions can be listed alphabetically near the beginning of the Rules document.
- Darbi Philibert then reviewed each definition with the Committee. The Committee removed some and edited others.
- Darbi Philibert motioned to accept the changes to the Definitions format and to the changes to the Definitions themselves. Brenda Martin seconded the motion. All members present voted unanimously in favor.

New Business

6. OTAC meeting dates for 2024.

- Members discussed how frequently OTAC meetings will be needed in 2024. All agreed
 that they should remain monthly until the Rules revisions are completed. There was
 general agreement that when they are completed, the frequency should decrease from
 monthly but be more frequent than the previous quarterly schedule in order to be
 responsive to practitioner issues and questions.
- Ingrid Franc to communicate with Dr. Van regarding available dates for 2024. They will be scheduled monthly but cancelled when no business is presented.

7. OTAC Leadership

- With Darbi Philibert's retirement from the Committee, a new Chair or Co-chair is needed. Dr. Van clarified that there is no set way for determining leadership. Ingrid Franc is willing to remain Co-chair but does not want to be a lone Chair.
