### **BOARD EDUCATION/ ENDS Items for DISCUSSION**

**Upcoming Events/Community Action** 

Northeast Delta's Prevention and Wellness Department concluded its virtual Phoenix Fitness Week from August 1-9, 2020. It was part of our integrated healthcare and regional fitness campaign. This wellness event was well received regionally.

Northeast Delta's Prevention and Wellness Department is collaborating with the LDH-OBH and the Louisiana Board of Regents to distribute NARCAN to regional colleges and universities. This collaboration is consistent with our ongoing college work around issues of suicide, alcohol and drug abuse, and mental illness.

Northeast Delta's Data Analytics Department has concluded analyses associated with our regional COVID-19 Social Impact Survey. The results webinar will take place August 20, 2020 at 2:00 PM via Zoom. The data associated with FY20 is being concluded and will be presented via Zoom. Additionally, our ULM Economic Impact Study will be released in the coming weeks too. These data and trends will be made available to the Board and general public as well.

Northeast Delta's alcohol ad campaign, done in conjunction with ULM, has begun to reach college age students regionally. The objective of the ad campaign is to bring awareness to the negative consequences of irresponsible drinking.

Dr. Monteic A. Sizer was contacted by Louisiana Department of Health's leadership about a White House visit that took place Tuesday, July 14, 2020. The visit included a conversation about the state's response to COVID-19. Dr. Sizer was asked to be in attendance as part of a small delegation to speak to the psychological effects of COVID-19, social determinants of health, and tele-health in rural communities based on our regional work.

Dr. Monteic A. Sizer and Mr. Chris Broadwater, interim chancellor at Louisiana Delta Community College, signed an MOU July 24, 2020, to provide U.S. veterans behavioral health and an array of educational services. Northeast Delta currently serves many regional veterans.
