We hosted a standing room only suicide awareness training Friday, April 5, 2019. The training was held at the Monroe Civic Center. 722 Louisianans committed suicide in 2017. Northeast Louisiana has seen an uptick in recent years of deaths caused by suicide. We have future trainings being scheduled to help mitigate this significant societal issue

We are co-sponsoring a regional suicide awareness walk/run Saturday, April 13, 21019 on the campus of ULM. It will begin at the ULM Activity Center. Registration begins at 8 am. The walk/run will be from 8:30 am to 11:00 am.

Dr. Sizer was the opening keynote speaker for Grambling State University's Behavioral Health Services for Children, Adolescents and Families Symposium.

Dr. Sizer and staff purchased and distributed sixty care packages for those residing at the Mary Goss nursing home. This is consistent with Operation Golden Years, a Northeast Delta senior initiative.

Our regional TV, radio and billboard ads are continuing to bring greater awareness to our agency and various initiatives. Our opioid media campaign has launched regionally.

Additionally, we will be hosting another statewide opioid summit sometime in June of this year. More details to come.
