# BOARD EDUCATION/ ENDS Items for DISCUSSION Upcoming Events/Community Action

NEDHSA and Mary Byrd Perkins Cancer Center signed a formal MOU and are hosting a range of cancer related screenings regionally. On Monday July 11, 2022, NEDHSA and Mary Byrd Perkins Cancer Center hosted colorectal cancer prevention screenings at NEDHSA's Bastrop Behavioral Health Clinic.

NEDHSA released its FY22 annual recap newsletter on Thursday, July 7, 2022. The newsletter highlighted all the innovative things NEDHSA did regionally in FY22.

NEDHSA and the Black Creatives Circle of Northeast Louisiana hosted a mural reveal in downtown Monroe June 30, 2022. This initiative has generated lots of regional media and community attention. We currently have murals in downtown Monroe, downtown Lake Providence, and on the campus of Grambling State University. The University of Louisiana at Monroe designed our traveling mural. Our traveling mural has been housed and showcased at several regional museums.

NEDHSA participated in a host of back-to-school events last week. For example, NEDHSA was in Lake Providence from  $\underline{10\text{am to }12\text{pm}}$ , in West Monroe from  $\underline{10\text{am to }1\text{pm}}$ , in Monroe from  $\underline{10\text{am}-2\text{pm}}$ , and in Tallulah from  $\underline{2\text{pm}-4\text{pm}}$ . Great agency information was shared with the community.

NEDHSA already made public its first independently evaluated six-month Rise Above Stigma results. NEDHSA recently concluded the final six-months of the report and made the entire report public. This work is unprecedented in our region and the state. A copy of the report will be made available to each Board member.

Dr. Sizer continues to share with staff that he expects that Northeast Delta will become fully integrated programmatically and across all business departments. Vendor supply chain issues have slightly delayed the full implementation of this aforementioned objective. To date, all fiscal policies and procedures, analytics, HR, technology, and facilities are being further aligned to support this agency objective. This objective is consistent with the Board-approved agency strategic plan and outcomes focus. We will see more significant innovations and larger population health improvements in Northeast Louisiana when this happens.
