Upcoming Events/Community Action

We had a great showing at our Sour Grapes psychodrama. We had about 600-750 people to attend.

Our prevention and wellness team conducted a responsible drinking training with local bar and restaurant owners. The goal was to help them prevent serving minors and to help reduce problem drinking.

We partnered with several regional school systems and sponsored more than 1,270 children and teens to learn about drug abuse and misuse. The children and teens also got a chance to learn about our Arts As Medicine Initiative, and tour the Northeast Louisiana African American Museum.

We are planning a meeting in Morehouse Parish to better understand the issues and challenges there in March. More information to come.

We chose 5 regional artists to produce artwork that reflects aspects of overcoming mental illness, addiction, and trauma. These pieces of art will be displayed at our upcoming downtown art crawl. The art will also be later displayed at regional museums.

We received a grant from the state to help identify and build operational capacity in regional nonprofits. These nonprofits will then help us further connect people to our mental health, addiction, developmental disability, and prevention and wellness services. These groups are to then become part of our regional safety-net service offerings.

I have established a regional training and professional development center at our new developmental disability building.

We are planning a cabaret style show at the Strauss Theater in March. More details to come.

We are preparing two manuscripts for publication in March. One is about client show vs no show rates, and the other one is about our behavioral and primary healthcare outcomes.

We are finishing repairs on our White Street, Ruston building location. This facility will house our second peer support center.
