Upcoming Events/Community Action -

NEDHSA received a 100% or perfect Louisiana Legislative audit. This was previously provided to each board member.

NEDHSA recently had its LDH OBH clinical audit. NEDHSA Ruston scored 99%, NEDHSA Monroe scored 99%, and NEDHSA Columbia scored 100%. These

audits primarily examined addiction best practices related to federal SAMHSA funding.

NEDHSA's HR dependent is preparing for an annual Civil Service audit. We expect to obtain a perfect or near perfect audit. The report will be made available to NEDHSA's Board upon completion.

NEDHSA is prepping for its CARF re-accreditation. CARF accreditation is one of the highest organizational standards in the world. We were awarded a three-year accreditation back in 2021. We also expect to be awarded another three-year accreditation. The accreditation report will be made available upon completion.

NEDHSA is on pace to open the state's largest inpatient facility for addicted pregnant women with dependent children. The twenty-four hour facility has more than ten thousand square feet and fifteen bedrooms. Each bedroom will be able to house up to three individuals each (mother, infant, and up to two dependents). NEDHSA published all of its innovative FY23-24 events and news in its annual wrap-up report. See the attached document and look inside your packets. Additionally, NEDHSA published its FY23-24 annual data and outcomes report. See the attachment and look inside your board packets. Both documents can also be found on NEDHSA's website.

NEDHSA sponsored the Biedenharn Museum & Gardens' "Scripture Through Many Eyes" Art Exhibition. "Scripture Through Many Eyes" opening reception is set for February 22 at 5 p.m. at Biedenharn Museum & Gardens, 2000 Riverside Dr., Monroe, La. This exhibition is part of NEDHSA's Art Is Medicine special initiative, an integrated health care, evidence-based prevention, communications, and treatment strategy to help serve persons with mental health, addictive disorders, and developmental disabilities. As part of NEDHSA's Art Is Medicine initiative, NEDHSA had its own commissioned mental health artwork showcased at the Northeast Louisiana African American Heritage Museum, Ruston Artisans Museum, and recently at the Union Parish Museum of Art and History.

Some parishes are receiving opioid money from the state. NEDHSA was encouraged to apply for Lincoln Parish's award. Let me know of other parishes who would like us to apply or assist in the execution of their award. We have the state's foremost opioid and harm-reduction model currently operating.
