I recently provided you Northeast Delta HSA's FY19 annual agency report. It highlights our work relative to the agency's strategic plan. I am happy to report that we exceeded expectations and continue to provide innovative regional programs and services.

Two ULM professors recently concluded an economic impact study of Northeast Delta HSA's influence regionally. The study revealed that we significantly contribute to the overall economy of northeast Louisiana annually. The report will be emailed for your review.

The succession plan and organizational structure remains the same.

Northeast Delta HSA has a series of webinars dealing with COVID-19 related grief, trauma, etc., beginning June 16, 2020. Weekly webinars will continue through June and into July 2020. This will be emailed for your review.
