Northeast Delta is having its highly anticipated Faith, Addiction and Trauma: Healing Our Communities Conference March 26, 2020. It will be held at the West Monroe Convention Center from 9:00 AM to 4:30 PM.

Northeast Delta hosted its JiggAerobics fitness event as part of its integrated healthcare model. We had hundreds to participate. It was held at the Monroe Civic Center on February 19, 2020 from 6:30 PM to 8:00 PM.

Dr. Sizer will be the keynote speaker during Grambling State University's 2020 Criminal Justice Reform Conference. It is part of their lecture series that is to take place on March 17, 2020. The location of the keynote address will be the Black and Gold Room.
