Upcoming Events/Community Action

We cut the ribbon on our new Child and Family Clinic May 5, 2022. The clinic is located at 2525 Ferrand Street in Monroe.

Northeast Delta's Prevention and Wellness team held two press conferences, one in Jonesboro and the other in Richwood to highlight agency opioid mitigation measures and place prescription drug take back boxes. This was done in partnership with Jonesboro's Police Chief and the Mayor of Richwood and staff. Prescription Drug Take Back events were recently held in these and other regional locations April 30, 2022. We were able to remove hundreds of pounds of prescription and illegal drugs from the streets.

We had a very successful Orange Ribbon Week (April 25-29). This week was designed to reduce underage drinking and to promote prosocial behaviors regionally

There was a Narcan training done with the Union Parish Sheriff's Office and the Union Parish Office of Homeland Security and Emergency Preparedness. The training was about the dangers of opioid related misuse, abuse, and death. These events were followed by a partnership press release, and will include a regional suicide training with city and emergencyresponse official.

We have commissioned the Black Creative Circle of North Louisiana to develop 5 Rise Above Stigma murals as part of our Rise Above Stigma initiative. One mural is located in downtown Monroe. The others will be placed in Franklin

Parish, Madison Parish, East Carroll, and Union Parish. These murals are in partnership with local municipal and leaders of local businesses to help reduce stigma to mental illness and encourage artistic regional development. We have done the same with ULM.

Our Rise above Stigma commissioned mural that depicts stigma-related scenes was displayed prominently on ULM's campus for two weeks. The display was also at the Northeast Louisiana African American Museum and the Union Parish Museum of History and Art. The mural is currently on display at the Chennault Aviation and Military Museum inMonroe.

We are also bringing back our regional psychodrama to highlight and destigmatize mental illness and addiction. The theatrical play, Alky, will occur May 27 and 28 for two showings, and it will be shown at ULM's Brown Theater. Doors open at 6:30 pm and the show will begin at 7 pm. This is a free public event and will likely be sold out both shows.

We continue to participate in many social media campaigns, including suicide prevention and various addiction ones. We have also started a massive Rise above Stigma digital public awareness campaign about stigma and our programs and services. This digital campaign includes Google, website, news banners, various social media outlets, etc.

We made public our independently evaluated six-month Rise above Stigma results. We aremaking excellent progress with this unprecedented anti-stigma campaign.

Dr. Sizer continues to share with staff that he expects that Northeast Delta will be fully integrated programmatically and across all departments by July 1, 2022. To date, all fiscal policies and procedures, analytics, HR, technology, and facilities are being aligned to support this agency objective. This objective is consistent with the Board-approved agency strategic plan and outcomes focus. We will see more significant innovations and larger population health improvements in Northeast Louisiana when this happens, and we will also be the first LGE to accomplish this.

For succession planning purposes, all protocols remain in place as provided to the boardpreviously to continue NEDHSA's operations seamlessly. Having such a plan is also consistent with our CARF accreditation. There is succession planning built into each NEDHSA department and my executive leadership structure. As a reminder, the ED's succession plan is the HR Director and the Integrated Care Director.
