Dr. Sizer spoke at ULM's Addictions Elderly Symposium (November 4). Additionally, Dr. Sizer spoke at the 17th Annual Together We Can Conference in Lafayette, Louisiana on November 14, 2019. He discussed the Intergenerational Impact of Louisiana's Opioid Crisis.

Prevention and Wellness hosted a series of prevention activities on the campus of ULM during their homecoming weekend. Sober tailgating, yoga stretching, etc., were included. Prevention and Wellness also partnered with ULM's Counseling Center and public relations students.

We are still working with Kia Richardson, a Ruston based attorney, to help execute criminal expungements for our non-violent mentally ill and addicted clients. Attorney Richardson is an experienced defense and expungement attorney. Ruston will be our pilot site. A listening session was held with Lincoln Parish leaders Tuesday, October 29th. Leaders included law enforcement, faith, business, civic, and governmental leaders. Board Chair Mike Shipp was also in attendance.

Chair Mike Shipp facilitated a follow-up listening session meeting on November 19th between Dr. Sizer, Ruston Mayor Walker and staff, and Ruston's Police Chief. There were several takeaways. Northeast Delta HSA staff members have started community outreach activities, prevention efforts, clinical positioning, etc.
