A. Proposed Rule Changes – Harry Schexnayder

1. LAC 7:XXV.141(M)

Motion: Mr. Jeff Hargrave made a motion to accept the proposed rule change to LAC 7:XXV.141(M). The motion was seconded by Mr. Jeff Porter and passed unanimously.

2. LAC 7:XXV.101 – Definitions – Inspection Diagram

Motion: Mr. Kevin Poole made a motion to accept the proposed rule change to LAC 7:XXV.101 – Definitions – Inspection Diagram. The motion was seconded by Mr. Bryan Billiot and passed unanimously.

B. Discussion of Rules - Harry Schexnayder

1. LAC 7:XXV.141(B)(4) - Rodding in Lieu of Trench and Treat

Mr. Mike Cohn gave a statement regarding Rodding in Lieu of Trench and Treat.

Motion: No motion was made regarding *Rodding in Lieu of Trench and Treat* LAC 7:XXV.141(B)(4). Tabled.

2. LAC 7:XXV.107 – License to Engage in Structural Pest Control Work

Motion: No motion was made regarding "4 years' experience w/in last 6 years – exceptions LAC 7:XXV.107. Tabled.

3. LAC 7:XXV.141(L) – Borates

Motion: Mr. Harry Schexnayder made a motion to change the title of LAC 7:XXV.141(L) from *Borates* to *Requirements for Wood Pre-Construction Treatments*. The motion was seconded by Mr. Bryan Billiot and passed unanimously.

C. LAC 7:XXV.145 – Wood Destroying Beetles

Motion: Mr. Jeff Porter made a motion to remove LAC 7:XXV.145 and allow pest control companies to treat for all wood destroying insects, including beetles, without having to identify an active infestation. The motion was seconded by Mr. Jeff Hargrave and passed unanimously.
