## **CALL TO ORDER**

The meeting was called to order by Mr. Bass at 9:38 a.m.

### AMENDMENTS TO THE AGENDA

**Motion:** Mr. Arceneaux made the motion for the commission to add a discussion of the department's approval of standard contracts under New Business. The motion was seconded by Mr. Kunst and passed unanimously.

### **PUBLIC COMMENTS**

There were no public comments.

#### **APPROVAL OF THE MINUTES**

**Motion:** Mr. Kunst made a motion to approve the minutes from the April 20, 2017 meeting as distributed. The motion was seconded by Mr. Arceneaux and passed unanimously.

# **OLD BUSINESS**

Mr. Schexnayder presented an updated Approved Termiticides and Manufacturers list for the Potpourri section of the Louisiana Register for approval. The commission discussed the addition of Termidor Foam and Premise Foam, and the removal of Torpedo from the proposed list.

**Motion:** Mr. Kunst made a motion to approve the updated Approved Termiticides and Manufacturers list in the Potpourri section of the Louisiana Register, with the addition of Termidor Foam and Premise Foam and the removal of Torpedo from the list. The motion was seconded by Mr. Arceneaux and passed unanimously

Mr. Schexnayder stated the updated list would also be added to the LDAF website.

The Commission discussed the use and interpretation of product labels and provided clarification that the department will enforce the strictest interpretation of the label. The department will bring this up at recertification meetings to ensure PCOs understand.

#### **NEW BUSINESS**

### LPMA Report – Jeff Porter

LSU/LPMA Summer Institute is currently happening. Greg Henderson (LSU Representative for the department ) has retired. LSU is in the process of interviewing his replacement, currently narrowed down to 3 candidates.

# SPCC Contract Review Committee - Joe Arceneaux

Mr. Arceneaux discussed the standard contract revisions presented at the meeting and requested for LPMA to poll the industry for recommended changes.

Mr. Kunst discussed having more representation of the industry on the Contract Review Committee.

The Commission discussed revising the standard contract regarding damage repair warranties and what is covered by the contract.

**Motion:** Mr. Arceneaux made a motion for the department and himself to revise the standard contract he presented at the Contract Review Committee meeting. This revised contract will better define what the word 'responsible' means and be presented at the January 2018 commission meeting. The motion was seconded by Mr. Rayburn and passed unanimously.

**Amendment:** Mr. Kunst made an amendment to the motion to have the revised standard contract presented to the Contract Review Committee meeting and invite members of the industry to have an opinion on the revisions, prior to the January 2018 commission meeting. Mr. Arceneaux accepted the amendment

# Amendment to the Agenda – Harry Schexnayder

Mr. Schexnayder discussed the department's authority to approve standard contracts without being presented to the Contract Review Committee if the contract revisions only pertain to the company name, information and logo.

Ms. Hunter will draft a resolution to present at the next Commission meeting stating the department's authority to approve those contracts without committee review.

#### SPCC Rules Committee – Harry Schexnayder

Ms. Hunter presented the rule changes discussed at the committee meeting.

Discussion regarding Rule 117(H) and setting a specific timeframe for the presentation of records upon request.

**Motion**: Mr. Kunst made a motion to revise rule 117(H) to specify that the licensee shall make a copy of records available to any employee of the department for inspection at a reasonable time during normal working hours within 48 hours upon notification. The motion was seconded by Mr. Arceneaux and passed unanimously.

The current draft of the standard waiver form was presented for review.

**Motion:** Mr. Kunst made a motion to approve the waiver form as presented. The motion was seconded by Mr. Arceneaux and passed unanimously.

Mr. Schexnayder presented the proposed changes to fumigation requirements in section 147.

**Motion:** Mr. Kunst made a motion to add (7) under section 147(A) stating "The licensee shall have all gas detection/monitoring instruments for the fumigant being used properly calibrated to meet manufacturer standards prior to the application of the fumigant." 117(3)(o) will be added requiring documentation of the instrument calibration. The motion was seconded by Mr. Arceneaux and passed unanimously.

Mr. Kunst announced his company, Fischer Environmental Services, has been sold but is still operating under the same name.
