Meeting Minutes

Approve Minutes

New business

- a) Slidell Police Department (Sandra Perrien) – Motion to approve Sandra Perrien, Secretary to the Chief was made by Toby Aguillard, seconded by Candace Oby. Motion carried. The Slidell Police Department Secretary to the Chief is classified under a municipal police employees civil service system.
- b) Oakdale Police Department (Lorrie Ann Johnson) – Motion to approve Lorrie Ann Johnson, Secretary to the Chief was made by Toby Aguillard, seconded by Candace Oby. Motion carried. The Slidell Police Department Secretary to the Chief is classified under a municipal police employees civil service system.
- c) Grand Isle Police Department (Marlana Bradberry) – Motion to defer Marlana Bradberry was made by Candace Oby, seconded by Toby Aguillard. Motion carried. Grand Isle will provide more information and a detailed job description for her application.
- d) University of New Orleans PD – Requested the Board to approve supplemental pay for UNO Officers based off of the June 2018 AG's opinion for SUNO. A motion to defer the approval of UNOPD for supplemental pay until they provide

an AG's opinion for University of New Orleans specifically was made by Toby Aguillard, seconded by Candace Oby. Motion carried.

- e) Youngsville PD (Half Pay) – A motion to defer the decision on half pay of supplemental pay was made by Toby Aguillard, seconded by Candace Oby. Motion carried.
- f) Franklin Police Department (Jordan Dorer) – Motion to approve Jordan Dorer's application was made by Toby Aguillard, seconded by Candace Oby. Motion carried.
- g) Gretna Police Department (Dustin Folsie) - – Motion to approve Dustin Folsie's application was made by Toby Aguillard, seconded by Candace Oby. Motion carried.
- h) Quitman Police Department (Christopher Tippen) - – Motion to approve Christopher Tippen's application was made by Toby Aguillard, seconded by Candace Oby. Motion carried.

Old business

- i) Southern University PD – Motion to remove the suspension of the Southern University Police Department Officers previously approved was made by Toby Aguillard, seconded by Candace Oby. Motion approved. Southern University provided a new AG's opinion dated June 5, 2018 that stated SUNO Officers are eligible for supplemental pay.
