Ted Thompson offered a motion to approve the minutes of the November 1, 2022 regular monthly meeting and Special Meeting on November 22, 2022, 2nd by Tommy Little. No opposition. Motion carried.

### VI. Additions/Deletions to the Agenda

### VII. Review proposals for terminal demolition and award project. (RFP# -WCA HL 11.22)

Darla stated that they sent out four RFP sets and only received one completed packet from D&G Construction. They are requesting that Tim Lafleur be given authority to execute the contract once it's ready.

Mike Granger offered a motion to approve giving Tim Lafleur authority to execute the contract for the terminal demolition project. (RFP# -WCA HL 11.22) with D&G Construction, 2<sup>nd</sup> by Ted Thompson. No opposition. Motion carried.

## VIII. <u>Approve NTE amendment to grant management Professional Services Agreement for Darla B Perry, CPA APC</u>

Darla stated that they had a Not to Exceed Professional Services Agreement for \$30,000, and they have almost reached that. They are requesting the NTE limit be lifted to \$90,000.

A motion was made by Tommy Little to approve the NTE amendment to grant management Professional Services Agreement for Darla B Perry, CPA APC, 2<sup>nd</sup> by Mike Granger. No opposition. Motion carried.

### IX. Finance Report

Darla Perry reported that July through October 2022 they budgeted \$240K revenue and they are at \$304K. The total expenses were budgeted at \$173,414 and they are at \$207,284. The net ordinary income was budgeted at \$28,836 and they are at \$6,753.

She also reported that FEMA reimbursement for Hangar B got approved and Hangar A & C have moved up a step. Reimbursement checks are also coming in much quicker.

Mike Granger made a motion to approve the Finance Report as presented, 2<sup>nd</sup> by Ted Thompson. No opposition. Motion carried.

#### XI. Engineer's Report

Chuck Stutes reported that they did the final walkthrough on the fencing project and the project is complete. The T Hanger project is in construction. The expected completion date is in March. Most of their work has been on the maintenance building.

They have released a set of agency review plans for the Terminal Building that are ready to be sent to FEMA.

The documents for Hangars A & C are at the contractor's office and he has 30 days to return those with his bond. They have received a fixed offer on Hangar B, so they are ready to go out for bids on that project.

Mr. Stutes also reported that he has talked to Keelan Construction on the pavement project. After the first of the year they should be ready to start.

Ted Thompson offered a motion to accept the Engineer's Reports as presented,  $2^{nd}$  by Tommy Little. No opposition. Motion carried
