Act 669 – Uniform Reporting for Collectors (Update)

 The document is posted to the LULSTB and LLA websites. ED Allen is working to post to the LATA website. The current version of the document is not editable. ED Lymon reached out to the LLA office for another version.

• Lookup tool – Hold Harmless Provision (Update)

- LULSTB Board recommended creating a rule in regards to a hold harmless provision. Executive Counsel recommended additional language to the document.
- Concerns about the Look Up Tool security. Stop gap measures have been put in place by IT consultant and Tax watch (i.e. Captcha).
- Question raised about longitude and latitude which only covers the land in Louisiana, not inland offshore (within the 3 mile limit).
