## **Reports of Committees**

#### **Administrative Committee**

There were no reports from the Administrative Committee other than that the legislature had been in session with regard to an overhaul of proposed cemetery laws.

## **Examination & Inspection Committee**

There were no reports issued from the Examination and Inspection Committee, but one report is expected at the November 3, 2023, meeting.

#### **Old Business**

a) Statewide Cemetery Response Task Force Report – Hurricanes Laura, Delta and Zeta

Dr. Seidemann gave a brief history of the Louisiana Cemetery Response Task Force, its members and functions. Dr, Seidemann indicated that almost all of the storms have been closed out by the State and by FEMA with the exception of a few remains which were left to be interred. He indicated that the task force continues to have two staging areas in Southeast Louisiana, namely in Plaquemine Parish and Jefferson Parish. Identification of the remains was ongoing.

### 11. New Business

- a) Late fee waiver requests The Director indicated that the following four late fee waivers were received.

After reviewing the request for waivers, a motion was made by Ms. Leufroy and seconded by Ms. Suggs that the waivers of late fees are approved, which Motion was unanimously approved.

- b) Request for travel approval
  - i) DCRA Convention in Little Rock, Arkansas

The Director indicated to the Board that a request for travel approval would be needed for four individuals to attend the DCRA Convention in Little Rock, Arkansas in October, 2023. A motion was made by Ms. Patin and seconded by Ms. Suggs that the Board approved the travel and lodging for the following individuals to attend the DCRA Meeting, which was unanimously passed:

## ii) Tri-State Cemetery Convention

The Director noted that the Tri-State Convention would be held in Perdido Key, Alabama and requested that he be permitted to attend to provide updated information regarding the changes in the law following the 2023 legislative session. A motion was made by Ms. Patin and seconded by Ms. Suggs hat the Board approve the travel and lodging, which was passed by unanimous consent.

# c) 2023 Legislation

The Director reviewed the various changes to the Legislation and indicated that there would be a further review of the policies and procedures of the Board to ensure compliance with the changes of the law, which policies and procedures would require approval by the Board prior to implementation. It was anticipated that a special meeting would be called by the Board to approve such policies and procedures once they have been prepared and presented to the Board.

## d) Sexual Harassment Training

The Director noted that all members of the Board are required to participate in sexual harassment training by the State and world secure the means by which members of the Board could attend such training.

# e) Louisiana Legislative Audit Update

The Director reviewed the legislative audit findings by the legislative auditor and provided a copy of the legislative audit findings to all members of the Board. It is noted that the legislative auditor had not conducted an audit of the Board for a period of five years, and the Director indicated that with a few exceptions there were no issues relative to the financial statements of the Board.

f) Discussion on establishing a future policy relating to disaster recovery/business continuity in the event of a catastrophic event.

The Director noted that the legislative auditor indicate that the best practices required the establishment of a policy relating to disaster recovery/business continuity in the event of a catastrophic event. The Director indicated that he would be securing forms from other state agencies and would provide the same to the Board at the fall meeting of 2023 for review and consideration
