**If accessing via Google Chrome:**

1. Go to join.zoom.us
2. Enter the Meeting ID number
3. Click Join
4. *Note:* If this is your first time joining a meeting from Chrome, you will be asked to open the Zoom client to join the meeting.
  - a. You will be prompted to open Zoom (“zoom.us wants to open this application”), click Open Zoom.

**If accessing via Microsoft Edge or Internet Explorer:**
